## **Panelist Bios:**

#### **Jeanne and David Sumnicht – Mayflower Church**

Jeanne and David have been members of Mayflower UCC for more than 35 years. Jeanne was the Moderator about 20 years ago and David was the Treasurer around the same time. Both have served on many committees in the Church. They were previously members of First Robinsdale UCC.

Jeanne is a retired elementary school teacher who spend more than 20 years in Edina Schools. David started in banking but spent most of his career as owner of several businesses including payroll systems, a planning and development firm and site based systems management. Currently David serves on the Board of the Foundation for Essential Needs, and has served on the Boards of Headway and VEAP in the past.

#### **Kevin Walker – Beacon Interfaith Housing Collaborative**

Kevin Walker has over twenty years' experience as a community development professional with deep experience in cooperative housing and affordable housing. He has worked as a consultant as well as in the nonprofit, for-profit, and public sectors, primarily on multifamily housing development projects throughout the Upper Midwest and elsewhere. He currently serves as Vice President of Housing and Shelter for Beacon Interfaith Housing Collaborative, an interfaith housing collaborative of about 100 congregations of multiple faith traditions, united in the vision that 'everyone has a home'. In this capacity, with a strong team, he oversees Beacon's housing development, operations, service partnerships, and congregation-based shelter program. Kevin has a bachelor's in political science from Swarthmore College and a Master's degree in City and Regional Planning from Cornell University.

#### Alan Arthur – Aeon

Alan has served as the President & Chief Executive Officer of Aeon since 1988. Alan brings almost 50 years of experience in housing and real estate development, including construction, project development, lending, code enforcement and city planning. He earned a B.A. in political science from Benedictine College in Atchison, Kansas. Alan trains organizations on affordable housing development, financing and organizational governance. He has served on numerous local and national housing boards, currently including the Housing Partnership Network's board of directors.
