# 1. Call to Order

Wiersum called the meeting to order at 10:47 p.m.

## 2. Roll Call

# A. Sept. 13, 2021 EDA meeting

Kirk moved, Calvert seconded a motion to adopt EDA Res. 2021-020 approving the 2022 EDA meeting schedule.

# C. Cliffs Settlement Agreement

Wischnack gave a report on this item, highlighting the background and history related to the settlement agreement with The Cliffs.

Commissioners offered questions and comments.

President Wiersum suggested amending the resolution to include a contingency that the settlement payment must be received by the end of 2021.

Ken Belgarde, of 7841 Wayzata Boulevard in St. Louis Park, provided comment and indicated the city will receive payment by the end of the year.

Kirk moved, Calvert seconded a motion to adopt EDA Res. 2021-021 approving the settlement agreement, amended to include language adding a contingency that payment be received by Dec. 31, 2021.

# **Background**

The Economic Development Authority (EDA) is governed by a set of bylaws that are the rules and procedures that define the organizational structure of the board. Bylaws include guidance on matters such as board size and membership, board officers, duties and powers, board authority, meeting procedures, financial matters, and miscellaneous procedural items. The bylaws for the Minnetonka EDA were first established in 1988 when the HRA was dissolved and the EDA was formed. The bylaws were last updated in <u>2021</u>.

## 2022 Election of Officers

Staff recommends the EDA elect officers for 2022.

## **Board Composition**

• The board shall consist of the seven commissioners that are members of the city council.

## Officers

- The officers consist of a president, vice-president, secretary, treasurer, and assistant treasurer elected annually.
  - The president will be a commissioner who holds the office of mayor of the city of Minnetonka.
  - The vice president will be the acting mayor of the city.
  - The treasurer will be a commissioner elected annually by the board.
    - The EDA should elect a treasurer at the Jan. 10, 2022, meeting.
  - The assistant treasurer shall be the finance director and may perform the duties of the treasurer.
  - The secretary shall be the city clerk.
  - The executive director shall be the city manager of the city of Minnetonka.
