Subject: About DEI

As we have witnessed in Minneapolis and other communities across the country, efforts to restrict and defund policing has resulted in massive increases in crime, homelessness and a decrease in quality of life for all residents except for the very wealthy. Policies that are a result of DEI initiatives destroy trust in local government and waste money.

A DEI commission is about political power structure and has nothing to do with building community. DEI has no place in Minnetonka which is already a safe and welcoming community for everyone. It works and does not need to be fixed.

As you look at policing statistics, ask yourself: is this really about racism, or is this more about a subculture of pervasive and dysfunctional civil disobedience not limited to race?
