Dear Sir / Madam:

I am the chief manager and owner of 5100 Thimsen LLC. 5100 Thimsen LLC owns an office building located at 5100 Thimsen Avenue, Minnetonka, MN near Highways 7 and 101. I am writing this letter to ask the City Council to immediately and decisively approve the license application for Sunshine Massage LLC.

I have been practicing law in the City of Minnetonka since 1982, and have been a partner in the ownership of this building and another office building across the street since 1987. My law practice is located at 5101 Thimsen.

When 5100 Thimsen LLC signed a lease with Sunshine Massage over three months ago, we were anticipating a 30-day license approval process, a very brief buildout consisting of new flooring and removing locks from the interior doors, and that the business would be up and running and paying rent in about 45 days. I did my due diligence in ensuring that the applicant / tenant would be compatible with our office building and other tenants. The other tenants include accounting, financial planning and insurance businesses and the tenants are looking forward to having a massage practitioner in the building.

I have reviewed the license denial letters, and here is what I have been told about the City's reasoning:

• In 2015, the applicant attended a Chinese massage school in Roseville, and in 2020, a state agency made allegations that the school had certain students and employees with connections to prostitution, which were never proven or admitted, and the massage department of the school subsequently closed down. No nexus has been suggested between the applicant's attendance in 2015 and the 2020 allegations against the school, other than the fact that she and some 400 other Chinese students had previously graduated from this school. While the City of Minnetonka has two alternate methods of qualification (education or experience), and the applicant was clearly qualified under the experience prong, the City found the allegations leading up to the school closure to be cause for denial, and then the City later realized it was in error.

• The "reconsideration" included a second, three-week long police investigation (for which applicant did not consent, and later learned there had already been a police investigation before the first denial), and was based upon 7 year old allegations on a private subscription-only offseas-based website, in which anonymous men can comment on alleged female prostitutes, which purport to identify the women by name and location of employment. There is no fact checking that is done, the website claims it is "fictional," the applicant was not aware of these allegations until she received the second denial, the city did not ask her about it, the allegations are vehemently denied, the applicant has taken steps to have these reviews removed, and the website has refused to remove these reviews. And the reviews misidentify the applicant by name, age, and apparel, are internally inconsistent, and refuted by other commentors. It is not known what steps the City has taken to make the original declarants of this hearsay available for cross examination.

I understand the City's concern in keeping out riffraff and illegal activity, and as a potential landlord and neighbor, I take the City's allegations and concerns seriously. I absolutely do not want trouble in my building and neighborhood. Now that I am aware of the city's "evidence", I still have no reason to believe that this business is going to be a front for illegal activity. I should note that unlike the people making these accusations, I have personally met the applicant. If I or other tenants have reason to believe that illegal activity is taking place, immediate and appropriate action will be taken.

This process has dragged on far too long. The City's dilatory tactics are highly concerning. I would like to think that the City of Minnetonka embraces diversity and inclusion.

I ask the City to take immediate and decisive action to approve this license.




