ELECTION 2023 What does a councilmember do?

This November, Minnetonka voters will head to the polls with the city's four ward councilmember seats up for election. Candidate filing opens Tuesday, Aug. 1.

Responsibilities

The Minnetonka City Council is the governing body of the city. The council includes a mayor, two at-large councilmembers and four Ward councilmembers, each representing a geographic area of the city.

The council is responsible for setting city policy, approving the annual budget and tax levy and establishing the city's strategic plan. Councilmembers also represent the city at public events and act as liaisons for various boards and commissions. The council appoints the city manager as the chief administrative officer of the city to oversee the city's daily operations.

Expectations

All municipal seats are nonpartisan. In setting policy, councilmembers make decisions through respectful dialog and collaboration that meet the needs of residents and constituents.

Time and Compensation

Serving as a councilmember is a time commitment. Councilmembers attend at least three weeknight meetings or study sessions per month, which typically last an average of three hours. In addition, councilmembers must be familiar with city issues, dedicate time to read council meeting agenda packets (typically 200 to 300 pages), follow up with questions and respond to resident inquiries. Effective Jan. 1, 2024, councilmembers receive an annual salary of \$18,000.

Eligibility

To run for Minnetonka City Council, you must be:

- Eligible to vote in Minnesota
- At least 21 years old upon assuming office
- Not running for another office in the upcoming election
- A Minnetonka resident at least 30 days before the general election

New Americans Academy breaks down barriers

Moving to a new country can come with a lot of challenges - and questions.

The Minnetonka Police Department and Minnetonka Community Education partnered this spring to offer a New Americans Academy to help people new to the United States learn more about the community.



The six-week program introduced participants to law enforcement, helped them understand their rights and shared information about area resources. Topic included visits from Minnetonka police, fire and recreation; information about elections and voting; and connections with local community resources, such as Sojourners and ICA Food Shelf.

"When you're new here, you might not know what those resources are, and by going through this course, you're able to get ... questions asked that you may not have been able to ask before," said Minnetonka Community Engagement Officer Chad Fierst.

For participants, the class was an opportunity to break down barriers, especially with law enforcement, and feel more connected to the community. Melina Arboleda says the experience helped her feel more comfortable with police officers.

"I feel like this program helped me understand police are humans, too. They are friendly. They protect us," Arboleda said. "This is a good program the city has. We can meet each other and we can share."

CODE CORNER Sheds and accessory structures

A **shed** is a type of accessory (detached) structure.

No building permit is needed for a shed that is 200 square feet or less, but a shed must:

- Be placed behind the front building line of the house or 50 feet from the front property line; and
- Meet all other minimum require setbacks and maximum area requirements for accessory structures.



An **accessory structure** is an uninhabited structure greater than 200 square feet, located on the same lot, subordinate to and associated with the principal structure. Depending on which district (R-1, R-2 or R-3) you reside in, specific uses rules (permitted, accessory or conditional) will apply.

When you decide to proceed, you will need a permit. Call the building division at 952-939-8394 or email **permits@minnetonkamn.gov** to confirm you have all of the needed information for the permit application process.

Steve Malecha set to retire in June

The 32-year veteran hangs it up this summer

The 1991 Halloween blizzard is a moment many Minnesotans remember, but few people had their entire lives changed by the storm. Steve Malecha is one of those folks. Thirty-two years ago, he was working as a cement contractor. His company laid him off due to the unprecedented weather.



"Working on the road, we always talked about working for a city," Malecha said. "I looked in the newspaper, saw the City of Minnetonka and I applied."

Out of 372 applicants, Malecha was selected. Malecha spent his first winter in Minnetonka working maintenance at the ice arena but quickly transitioned to the street division.

From curb and gutter repair, utility digs and, of course, snowplowing, Malecha has had to wear many hats over the last three decades. "You name it, I've done it."

In 2010, Malecha was promoted to street field supervisor. Today, he's in charge of 18 public works employees, managing schedules and assigning duties.

What's the most difficult time of year for scheduling? You guessed it: winter.

"When we have a snowstorm...I make sure every route is full, and every cul-de-sac route is full," Malecha said.

Even with all that responsibility Malecha doesn't really think of himself as a boss, though. "I never looked as myself as a supervisor," he said. "I'm just a guy that keeps stuff somewhat organized."

That sense of humility has made an impression on his coworkers and managers. "Steve's a real easy going guy," said Public Works Director Will Manchester. "The crews love him, and they work well together."

Nevertheless, Minnetonka Public Works will continue their work without Malecha, and while the next person will, as Manchester says, have big shoes to fill, Steve's humility has provided great opportunities for the next group of leaders and leaves the city in a good place.

Malecha, on the other hand, is looking forward to retirement. It will include extended trips at his family cabin. He'll take special note of the first snowfall this winter.

"I won't have to get my boots on and clear the drive at 4 a.m.," Malecha said. "For the first time in years, I can just let it snow."

MORC is hard at work at Lone Lake Park

While many Twin Cities mountain bikers dream of escaping to destination trail systems, access to local, purpose-built trails offers a fun and easy way to keep the legs fresh, close to home.

Completed in November 2020, the five miles of singletrack mountain bike trails at Lone Lake Park are helping grow the sport and build something new.

"Access builds community," said Eric Ekstrand, dirt boss of the local Minnesota Off-



Road Cyclists (MORC) chapter. "And in a powerful way, the Lone Lake Park mountain bike trail has done just that. It's difficult to quantify, but the new trail has brought a community together."

The City of Minnetonka and the local chapter of MORC maintain and manage the trail. Approximately 160 dedicated build volunteers contributed more than 1,000 hours to the trail construction process.



Last year, 66 MORC volunteers contributed nearly 500 hours toward trail maintenance and 200 hours for park restoration.

If time and sweat weren't enough, these same volunteers partnered with Unmapped Brewery in Glen Lake to create the

Cycle Unmapped bike group with bikers of all ages and skill levels. Since opening the trail, Cycle Unmapped has grown to more than 70 weekly bikers who meet on Thursday nights to ride the trail.

The city appreciates the dedication of all our Minnetonka MORC volunteers. "Without the work of our partner volunteers, none of this would be possible," said Minnetonka Program Manager Jesse Izquierdo.
