Thank you for your prompt responses Bradley and passing along our note to the City Manager. Understanding there is no vote tonight, we do have some initial feedback after reading the ordinance draft that will be reviewed.

- 1. Distance from public arenas, bus and transit stops is too small.
- 2. The state language of a violation "anywhere a child maybe" is a core issue. While the Clean Indoor Account addresses inside of businesses, it does not address privately owned outdoor spaces that support businesses like parking lots. We think of the lots at 101 and Minnetonka Blvd and at Target(s) as examples where minors are present on a regular basis. Should these types of locations be treated like open bottle regs around alcohol?
