Please Note:

- Permits for sewer and water work in a new structure, or within 24 inches of the outer foundation of a new or existing structure, will only be issued to contractors licensed by the State of Minnesota.
- Installation and materials must conform to MN Plumbing Code 4714 Chapter 6 and 7.
- If a sewer liner is proposed, a pre-liner video must be submitted to the Plumbing Inspector for review and approval prior to the liner install per the 2020 MPC 715.3.
- If any type of sewer ejector, lift station, etc. is proposed, plans showing piping diagram and materials, along with an application for alternate methods and materials must be submitted per the 2020 MPC 301.3.

Permit Fees. Fees are based on the valuation of the work being proposed. Valuation includes materials, equipment and labor cost to complete the project. When materials, labor, or installation will be furnished by another party, the reasonable market value of those items must be included in the valuation.
