### The Landings at Minnetonka

The Landings at Minnetonka is operated by Stonecrest Living as an assisted living facility licensed pursuant to Section 144(g) of Minnesota Statutes. At the present time, there are 78 residents living at the facility, which has a total capacity to serve 90 residents. The residents lease living facilities at the property and the operator's license permits Stonecrest to provide the following services within the following categories:

#### **Home Management**

-Homemaking (Housekeeping, Laundry)
-Shopping
-Money Management
-Assistance Making Appointments
-Arranging Non-Medical Transportation
-Socialization

## **Congregate Meal Preparation**

The facility prepares on site and serves breakfast, lunch and dinner daily. Residents cannot cook in the rooms but the facility has small prep areas and kitchenettes for residents to use to make snacks

## Transportation

Currently seven residents own a vehicle and the rest do not own a vehicle.—a ratio that should remain consistent with expansion. The Landings provides transportation to all residents, scheduled 24 hours in advance. Transportation is available for a wide range of purposes including appointments, outside cultural and social activities, family visits, recreational outings and the like. The facility has three fulltime drivers during the AM shift and two on the PM shift, 7 days a week. Same day transportation is provided in emergency situations

## **Cognitive and Behavioral Management**

In addition to the other services described above, the Landings also provides mental health management services. The facility employs two full time nurses that specialize in cognitive and behavioral management, plus a social worker and an administrator with extensive background in mental health management, along with partnering with several agencies such as onsite medical providers, IHS workers, and ARHMS workers. Depending on the assessment findings the professionals at the Landings create a care plan that addresses interventions and staff responses to mental health management. Staff works with a local pharmacy to ensure medication management -- especially for mental health medication, while also working directly with psych providers to ensure mental health symptoms are managed and stable.

The Landings does <u>not</u> provide program services such as alcohol or substance abuse treatment programs, mental health treatment programs or sexual offender treatments programs. These types of programs are outside of the operator's license. To the extent any resident desires or needs such programs, they leave the premises for treatment, just as they would for medical treatment or physical therapy or any other services.

Many residents suffer from traumatic brain injury (TBI) and as a result have diminished cognitive abilities or suffer from other related mental developmental or intellectual capacity issues. These resident characteristics are typical of an assisted living facility in Minnesota.

The current resident group ranges in age from 27 to 74. Age is not a differentiating characteristic in terms of resident needs.

proposed first floor plar new building area









south elevation Z
