YOU'RE INVITED

The City of Minnetonka is proposing a trail project along the north side of Minnetonka Boulevard, from Tonkawood Road to The Marsh. **See the reverse side for a map of the proposed project area.**

You're invited to an informational meeting to learn more, provide input and ask questions about the proposed improvements. City staff will discuss the project schedule, potential impacts and communications plan. Drawings of existing conditions and conceptual improvements will also be available.

WHAT IS BEING PROPOSED?

The project includes construction of an eight-foot wide, multi-use paved trail for pedestrians and bicyclists. Private utility companies will also bury overhead power and communication lines during this project, along with replacements of gas mains. The project aims to improve safety, mobility and connectivity along Minnetonka Boulevard. Trail construction is planned for 2026, with private utility work occurring ahead of the city's project in 2025.

The proposed trail will look very similar to the previous trail segment constructed in 2023 between Woodlawn Avenue and Tonkawood Road.

POTENTIAL PROJECT IMPACTS

Projects of this nature can be disruptive. Residential and business access will be maintained, but there may be times with limited and alternative access. During construction, there will be additional traffic control on Minnetonka Boulevard, which may require temporary lane shifts, flagging and detours. The city will work to minimize these impacts as plans are finalized.

IF THIS PROJECT IS APPROVED, WILL I BE ASSESSED?

No, property owners will not be assessed. These improvements are funded through the city's Trail System Expansion Fund.

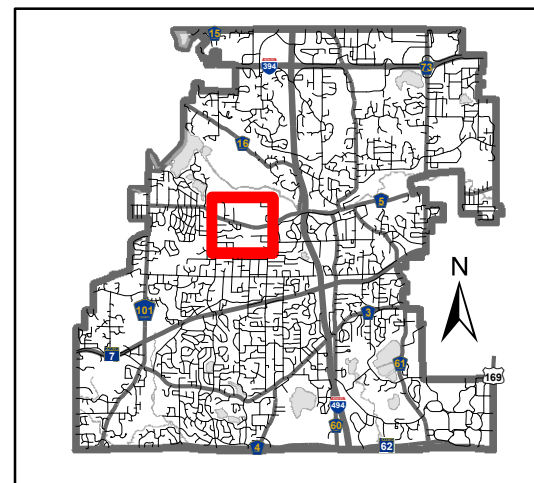
