Garden plots for rent March 7

If you're interested in Gardening but don't have the property or the space for a garden plot, then a community garden plot might be the answer for you!

Recreation services offers garden plots for rent each year to residents of Hopkins and Minnetonka, for the sole purpose of gardening. For residents of both cities, plots are available for rent starting March 7. Non-residents may purchase plots starting March 14. Registration is in-person, on a first-come, first-serve basis. Proof of residency is required. Register early — these plot sites fill quickly!

Minnetonka

The city of Minnetonka garden site is located at Excelsior Boulevard and Purgatory Creek. Minnetonka plots are available for rent only in-person at the recreation department at Minnetonka City Hall, 14600 Minnetonka Boulevard, Minnetonka. There is a limit of two plots per household. Fees are \$15 for each 20'x20' plot. For more information, call (952) 939-8203.

Hopkins

The city of Hopkins provides a garden site area in Hopkins Valley Park in the Westbrooke/Nine Mile Creek area, where

residents can rent a 20'x20' garden plot. Hopkins plots are available for rent only at Hopkins
City Hall, 1010 First St. S.,
Hopkins. Due to the high demand for plots, there is a limit of two plots per household. The new fee is \$20 for one plot, and \$50 for two plots. For more information, call (952) 935-8474.

Sponsored by the cities of Minnetonka, Golden Valley, Hopkins and St. Louis Park, as well as Hopkins, St. Louis Park and Minnetonka community education, the Home Remodeling Fair is designed to promote improvements to these communities' housing stock.

Local student wins Minnesota Chiefs of Police Association essay contest

In December, Minnetonka Police Chief Mark Raquet visited Hopkins North Junior High in Minnetonka to present eighthgrader Kaitlyn Ho with an award certificate and \$100 check for being one of 37 winners statewide of the Minnesota Chiefs of Police Association's essay contest describing the good uses of electronics and technology.

The contest, sponsored in part by the Minnetonka Police Department, encouraged youth to think about how they can use personal phones and computers in constructive ways, and about how individuals, organizations and communities can integrate the use of technology toward thoughtful and benefit causes.

The essay contest was also backed by the Minnesota Bureau of Criminal Apprehension, which has invested years of research and expertise in education and training about appropriate and safe use of technology for kids.

The Minnesota Chiefs of Police Association is a private, non-profit organization, started in 1954, that currently serves a membership of 320 chief law enforcement officers in the state.

Safety first: Check your CO detectors and adopt a fire hydrant

the Minnetonka Fire Department's public educators want you to be informed about two important safety concerns: carbon monoxide poisoning and fire hydrant accessibility.

Carbon monoxide (CO) is a poisonous gas that you cannot see, feel, taste or smell. It is a byproduct of combustion, typically caused by malfunctioning or improperly vented furnaces and/or water heaters in your home. Sometimes

idling motor vehicles in your attached garage can cause carbon monoxide issues in your home. Carbon monoxide poisoning is extremely dangerous and can happen to anyone.

Symptoms of carbon monoxide poisoning are similar to the flu and include nausea, confusion, headache, weakness and dizziness. If all members of your household have these symptoms at the same time with relatively sudden onset it is best to get out of your home and call 9-1-1. As of August 1, 2009, it is a Minnesota state statute that all households must have a working carbon monoxide alarm within 10 feet of all bedrooms. The only way to know you may

have a carbon monoxide issue in your home is by having working carbon monoxide alarms.

Secondly, we ask that residents work to keep the fire hydrants in their neighborhoods accessible. Fires grow very fast and the ability of our firefighters to access hydrants quickly can be the difference between extinguishing a small kitchen fire and dealing with a fully involved house fire. Please be considerate of your neighborhood and keep those hydrants accessible year round. The house you save may be your own!

Enjoy your winter and remember to install or check your carbon monoxide alarms today! ••

Municipal utility fee changes effective January 1

AT ITS DECEMBER 20, 2010, MEETING the Minnetonka City council increased municipal utility (water, sewer, and storm water) fees effective January 1, 2011. Changes to the fees are as follows.

- Residential water rate tiers were restructured to encourage greater water conservation. Tier 1 was adjusted so the upper cutoff was reduced from 25,001 gallons to 18,001 gallons. As a result, the lower cutoff for Tier 2 was reduced from 25,001 gallons to 18,001 gallons. The other tiers are unchanged. This modification conforms to Minnesota Department of Natural Resources guidelines for water conservation.
- Residential rate tiers are now applied to multi-unit apartment buildings.
 Water bills for multi-unit apartments will be calculated by multiplying the number of residential units in the building times each tier volume threshold. For example, two residential units in a single building will expand all the tier cutoffs by a factor of two.
- Water rates were increased by 3.5% and sewer rates increased by 4.75%. Since utility rates were last increased in 2009, this increase brings rates into line with operating costs and allows for increases passed on to the city by the Met Council for sewage treatment.
- Stormwater rates were increased by **6.25%.** : Since stormwater utility fees were also last increased in 2009, the 2011 increase ensures revenues cover the costs of the city's storm water system infrastructure as well as federally mandated analysis and reporting on water quality. The city's topography and development history require storm water system improvements to be made in conjunction with street reconstruction programs. Stormwater fees support these improvements as well as projects to correct residential street flooding, included in the city's five-year Capital Improvement Program.

In order to encourage water conservation and to reduce the overall costs of the water system for all customers, the tiered rate structure for both residential and commercial customers continues. The table to the right shows the rate increases for 2011.

Grants available for natural resource projects

THE NINE MILE CREEK WATERSHED
District is offering a Best Management
Practices (BMP) Cost-Share/Grant Program
for efforts that protect and improve water
and natural resources within the Nine Mile
Creek watershed.

Funds may be used by public or private landowners for projects that support one or more of the following:

- Improve water quality or increase the capacity of the watershed to store water;
- Preserve, protect and restore native plant and wildlife communities, with emphasis on lakes, rivers and wetlands;
- Protect and preserve groundwater quality and quantity.

The BMP Cost-Share Program will provide grants up to 75% of the total cost of the project on a reimbursement basis. The maximum grant amount is \$3,000 for residential projects, \$10,000 for lake and townhome associations and \$25,000 for commercial and government projects. The minimum grant amount is \$500. Projects completed or in progress when approved are not eligible for funding.

Projects applications will be accepted starting January 1, 2011, through April 1, 2011. DEVELOPMENT DETAILS

DEVELOPMENT DETAILS IS A new feature in the *Minnetonka Memo* highlighting larger building projects in the city. Watch for this feature quarterly in the *Memo*. If you have questions about any of these projects, contact Minnetonka City Hall at (952) 939-8200.

Generally, the city of Minnetonka has experienced an overall increase in all types of building permits, up from 4,800 in 2009 to more than 5,400 in 2010. In addition, about 21 new homes began construction in 2010 — twice the amount as in 2009.

Minnetonka residents may notice several projects beginning or continuing in the upcoming months:

UnitedHealth Group started construction in November on the second building of its headquarters campus, located in the Opus business park near the northwest corner of Hwys. 169 and 62 (Crosstown). This second building is 11 stories with 350,000 square feet, and includes a parking ramp for 1,250 vehicles. Along with the first headquarters building, which is 10 stories tall and 350,000 square feet, and a third existing building on the campus, UnitedHealth will have total office space of more than a million square feet.

In March, works starts on the expansion of the Hwy. 169 and Bren Road interchange into the Opus business park. The city of Minnetonka has won several awards for its creation of a unique funding structure using multiple public and private resources, as well as traffic counts generated by new commercial development, to finance this project without burdening the general taxpayer. The project is expected to be completed by November of 2011 and will allow for future development and expansion of the business park. If you frequently travel in this area, visit www. eminnetonka.com for information on how to receive updates on road closures or traffic impacts related to this project.

Whole Foods will move into the space on Plymouth Road previously occupied by Circuit City. A traffic study has been completed, and the city has worked through some identified issues to ensure safe traffic patterns in the area. The city

is very pleased to welcome a tenant to this previously vacant big-box space, as these are often very challenging to fill. The project should open in November 2011.

The **Goodwill** store opened at the beginning of November 2010 in the building previously occupied by HomeValu, on the north side of I-394. The newly renovated building is a boost to the appearance of this commercial area, and the city continues to work with Goodwill to ensure it is a good neighbor to those living in the nearby residential neighborhood.

Noodles & Company will fill the space previously occupied by the Creative Kidstuff store in Ridgehaven Square North on Ridgedale Drive. This project is underway and should be open by spring.

Construction continues on **St. Therese** in Glen Lake. This latest addition to the Glen Lake neighborhood will provide 150 independent, assisted living and memory care units along with associated common use facilities and underground parking. The project is slated for completion in early 2012. In addition, work on the **Glen Lake Station Plaza** was substantially complete this fall, including a fountain, and will be available for everyone to enjoy this spring.

MGM Wine & Spirits and Walgreens, both located near Highway 7 and County Road 101, will be switching places over the next few months. Walgreens will occupy the current MGM store west of County Road 101, while MGM will move to a temporary location in Westwind Plaza until they can remodel the Walgreens space. All final moves should be complete in mid-2011.

City recognized for excellence in financial reporting

The Certificate of Achievement is the highest form of recognition in the area of governmental accounting and financial reporting, and its attainment represents a significant accomplishment by a government and its management.

The CAFR was judged by an impartial panel to meet the high standards of the program including demonstrating a constructive "spirit of full disclosure"

Tree pruning dropoff opens in March

THE CITY FORESTER RECOMMENDS
November through March as the ideal time to prune oaks, as they are least susceptible to oak wilt disease during these months. This is also a great time to prune other trees, since insects and diseases are not active.

To assist residents who conduct proper winter pruning, the drop-off site at the Minnetonka Public Works facility (11522 Minnetonka Blvd.) will be open Saturdays, March 5, 12, 19 and 26, from 7 a.m. to 3 p.m.

The site will not be open weekdays in March. The regular brush drop-off program starts Monday, April 11.

Branches up to 12" in diameter will be accepted. Christmas trees (without plastic bags, stands or decorations) will also be accepted. Proof of Minnetonka residency—driver's license or Minnetonka utility bill—is required to drop off brush.

Please note: trash, grass, leaves, dirt, sod, lumber, fencing, or wood scraps are **not** accepted.

No brush or trimmings will be accepted from commercial tree or lawn services. •

Use caution on frozen lakes and ponds

ANY TIME YOU STEP ONTO A frozen body of water to ice skate, ice fish or walk you are taking a risk. Don't assume ice is safe because temperatures have been cold — thin or unstable ice is always a possibility. Ice can shift, and underwater springs can create unstable ice. Know the condition of your lake or pond, use caution and be safe.



City tree sale orders due by March 1

HE TREE SALE PROGRAM IS BACK TO help you diversify the tree species in your yard. Learn more about the species offered and which ones are best suited for the conditions in your yard at www.eminnetonka.com. Paper packets describing the trees are available at city hall and public works. Be sure to turn in your order as soon as you decide, since quantities are limited and based on nursery availability. The most popular species sell out within a few days. The earlier we receive your order, the better the chance to get your top selections. If you have a yard full of ash, then this is a good time to get other trees established before Emerald ash borer arrives in Minnetonka.

Ordering trees

- This offer is open to Minnetonka residents only. The city is offsetting the cost of the trees for residents, since the intent of the sale is to reforest the city of Minnetonka. Please refrain from buying trees for cabins or for others who do not live in the city.
- You may order up to two trees per property. Orders will be processed for single family homeowners along with town/twin home and condo associations.
- If you represent a homeowner's association, you must contact the city forester prior to placing your order.
- Along with the tree order form, please fill out your name and address on the postcard to ensure you receive your order confirmation and reminder two weeks prior to the tree pick up. Enclose the postcard in the envelope with the order form and check. The city will fill in the quantity of each tree reserved once we receive your order.
- You may mail in your order or drop it off in person at Minnetonka Public Works (11522 Minnetonka Blvd — next to the Big Willow ball fields) between 7 a.m. and 3:30 p.m. Monday through Friday. If you drop it off at city hall there will be a one-day delay in processing it.
- You may check the city's website at www.minnetonka.com prior to mailing your order to see if your species are still available.
- The white guards that are on the trees on the day of the pickup are only temporary for shipping purposes and should be replaced with a taller, larger diameter tree guard (or welded wire caging for the conifer species).



 - Tour de Tonka, an annual Minnetonka Community Education multi-distanced bicycle ride through Lake Minnetonka communities for cyclists of all ages, promotes and celebrates healthy lifestyles, friendship, teamwork and recreation through the collaboration of cities, sponsors, local charities and

hundreds of volunteers. In just five years, there have been 8,423 riders—2,425 in 2010 alone, with nearly \$3,000 raised this year for the ICA Foodshelf.


