2008 state primary set for Tuesday, September 9

EDERAL, STATE, COUNTY AND JUDICIAL offices are on the ballot for the State Primary Tuesday, September 9. No local issues are on this year's ballot. The purpose of the primary is to determine the candidates who will advance to the November 4 General Election.

Absentee Voting

Absentee voting is available for those who are unable to get to the polling place on Election Day due to:

- absence from the precinct, illness or disability;
- religious observance;
- and/or service as an election judge in another precinct.

Absentee voting is currently underway and may be done in person or by mail.

In Person

Minnetonka voters may vote absentee at the Minnetonka City Hall or at the Hennepin County Government Center in Minneapolis during regular business hours, 8 a.m. to 4:30 p.m. Extended absentee voting hours will be available at both locations Saturday, Sept. 6, 10 a.m. to 3 p.m., and Monday, Sept. 8, until 5 p.m.

By Mail

The first step to vote absentee by mail is to complete an application, which may be obtained by calling city hall, visiting **WWW**. eminnetonka.com, or faxing a request to (952) 939-8244. Upon receipt of an application, the city will mail a ballot with instructions. Remember, the voted ballot must be received at city hall by Election Day for the vote to count - please allow sufficient time for mail delivery.

Registering to vote

Pre-registration for the Primary Election closed August 19 to allow the county time to update the precinct voter lists for Election Day. However, Minnesota allows voters to register to vote at the polls on Election Day.

Other Election Information

Polls will be open for the State Primary Tuesday, September 9, from 7 a.m. to 8 p.m. Results will be posted on the Minnesota Secretary of State's Web site at

www.sos.state.mn.us and the Hennepin County Web site at *www.hennepin.us.*

There have been two polling place changes since 2007: voters in Ward 4 Precinct C and Ward 4 Precinct H will now vote at the Minnetonka District Service Center at 5621 County Road 101. Notices were sent to those affected voters in August. All other polling locations in the city have remained the same.

Looking ahead to the Nov. 4 election

ELECTION DAY IS SET FOR TUESDAY, November 4. Federal, state, county and judicial offices will be on the ballot. Information about absentee voting is below. Look for more information about Election Day in the October 2008 *Minnetonka Memo.*

Absentee Voting

Absentee voting is available for those who are unable to get to the polling place on Election Day — Tuesday, November 4 — due to:

- absence from the precinct;
- illness or disability;
- religious observance;
- or service as an election judge in another precinct.

Absentee ballots for the November 4 State General Election will be available beginning October 3. Residents can absentee vote in person at city hall or the downtown Hennepin County Government Center, Monday through Friday from 8 a.m. to 4:30 p.m. Extended absentee voting hours will be available Saturday, November 1, 10 a.m. to 3 p.m., and Monday, November 3, 8 a.m. to 5 p.m.

Absentee voters can also vote by mail. Visit the city's Web site to download the absentee application or call city hall at (952) 939-8200. The completed application can be mailed or faxed to Minnetonka City Hall and the ballot will then be mailed out. The voted ballot must be returned in time for it to be counted on Election Day.

Options are available for voters who will be out of the country and wish to cast an absentee ballot. For more information on the overseas absentee voting process, call city hall at (952) 939-8200.

Turnout for the November General Election is expected to be extremely high nationwide. Voters can expect to encounter lines throughout the day, although voter turnout is usually lightest during the late morning and afternoon hours. To avoid frustration, be sure you know your correct polling location. Visit *www.eminnetonka. com* or call Minnetonka City Hall at (952) 939-8200 for poll locations.

Since 2007, two polling places have changed: voters in Ward 4, Precincts C and H will now vote at the Minnetonka District Service Center, 5621 County Road 101, Minnetonka. Notices were sent to affected voters in August.

What ID do you need to vote?

Voters registering to vote on Election Day must provide proof of residence.

You may show one item from Table A or two items from Table B (valid photo ID plus valid utility bill)

On Election Day you must have one of the following:

- Valid Minnesota driver's license or learner's permit (or receipt for either) showing current name and address in the precinct.
- Valid Minnesota identification card (or receipt) showing current name and address in the precinct.



- Tribal ID showing current name, picture, signature, and address in precinct.
- A voucher card signed by the person vouching for the voter and witnessed by an election judge. A voucher is the oath of a voter registered in the precinct who can verify the registrant's address in the precinct.
 - The voucher must have personal knowledge of the person for whom they are vouching.
 - A voter who is vouched for **cannot** vouch for another voter at this election.
 - Challengers cannot serve as vouchers.
 - A voucher may vouch for up to 15 voters.
 - Voucher must leave the polling place as soon as the vouching process is complete.
- Late notice sent from the City Clerk.
- Prior registration in the same precinct—voter's former address listed in the polling place roster.
- Current students
 - Student ID or dated registration or fee statement with valid address in the precinct.

OR

On Election Day voters may register by a combination of one picture ID from Column 1 along with one type of utility bill from Column 2.

Column 1

Approved photo IDs must contain voter's name and photo. It may contain voter's old address or have no address.

- MN driver's license
- MN state ID
- U.S. passport
- U.S. military ID
- Student ID from MN postsecondary school
- Tribal ID

Column 2

Approved utility bills must contain name, current address in the precinct, and date due within 30 days before/after Election Day.

- Water/sewer
- Cell phone

Safety tips for children who are home alone

WORKINGS PARENTS EVERYWHERE SHARE THE ANXIETY, frustration and even fear involved in leaving children alone when school lets out. What do you do when children are too old for day care, but far from grown up? To help determine if your child is ready to stay home alone, ask if your child can:

- Be trusted to go straight home after school?
- Easily use the telephone, locks and kitchen appliances?
- Follow rules and instructions well?
- Handle unexpected situations without panicking?
- Stay alone without being afraid?

Before leaving a child alone, teach them:

- How to reach you. Make sure important numbers are posted by the phone. Consider one of the new kid-friendly cell phones with parental control.
- To check in with you or a neighbor immediately after arriving home.
- How to dial 9-1-1.

- To never accept gifts or rides from people they do not know well.
- How to use the door and window locks, and alarm system, if you have one.
- To never let anyone into the home without your permission.
- To never let anyone at the door, or on the phone, know that

they're alone. Instruct them not to answer the door and/or to say that "Mom or Dad can't come to the phone right now."

- To carry a house key with them in a safe place.
- How to escape in case of a fire.
- To let you know about anything that frightens them or makes them feel uncomfortable

Most importantly, talk about staying home alone with your children and listen to their concerns and ideas. Work out rules about having friends over,

homework, household chores and television. And remember, staying at home alone when the child is ready can build self-esteem, responsibility and practical skills. ∞

Start your cameras for the 2008 photo contest!

THE CITY OF MINNETONKA AND THE Minnetonka Community Commission will once again host a photo contest this year in conjunction with the Fire Department and City-Wide Open House. Read on for this year's contest rules!

- Photographers must be residents of Minnetonka.
- Entries must be submitted by the original photographer. Do not submit a photo taken by someone other than you. Your submission of the photo and entry form is your guarantee that you are the author and copyright holder of the photo.
- Photos must be appropriate for posting in city government publications. Photos containing recognizable people must be accompanied by a signed model release form (available online at **www. eminnetonka.com**).
- Entries may be color or black-and-white prints or digital images. If you submit prints, you are encouraged to also submit a digital image, if possible. Specific rules regarding digital images are listed below.
- Prints must be 4x6 or 5x7 inches. Do not send negatives. Attach a label to the back of each print with your name and address. Do not write on the photo itself. If submitting multiple entries, number each print to match a corresponding entry form (see form below). Up to three entries may be submitted.
- Submit each photo in one of three categories:
 - Minnetonka Lifestyle (cityscapes, buildings, people, activities, etc.)
 - Natural Minnetonka (landscapes, plants, animals, etc.)
 - Enhanced Minnetonka (photos significantly altered by editing software, such as a photo collage, etc.)
- Photos, regardless of the medium, will not be returned. Please do not send your only copy of a photo. All photos become the property of the city of Minnetonka and may be used on the city's Web site and in city publications.

Digital Images

Digital images should be emailed to *jlarson@eminnetonka.com* or submitted on a CD. Please note that some photo files may be too large to be emailed. Images should be submitted in JPG (high quality) or TIFF format. Please submit digital images at the original size and resolution at which they were taken. Images must be in natural color. Black and white images will be accepted, but sepia tone and duotone images are not eligible. Digital images will not be returned.

Image Modifications:

Minor digital enhancement is allowed, but images that have been significantly modified or appear unnatural will be disqualified, unless they are entered in the "Enhanced Minnetonka" category.

Deadline

All photos and digital images must be submitted by Wednesday, October 1, 2008,

at 4:30 p.m. and will be displayed at the Fire Department and City-Wide Open House Tuesday, Oct. 7, from 5 to 8 p.m.

Awards

A first-, second-, and third-place entry will be selected. First-prize winner will receive \$75; second-prize winner will receive \$50; and third-prize winner will receive \$25. Rings and buds, scars and branches — how a tree grows

You notice your trees growing larger each year, but have you ever stopped to wonder how they grow? For example, if you hang a bird feeder on a low branch, does the feeder slowly move out of reach as the tree gets taller? Why or why not? It's important to understand how a tree grows, because it should influence how you care for your trees.

Tree growth is essentially the increase in size and numbers of leaves, stems and roots, which contain meristematic tissues — areas where actively dividing and growing cells are located. The seasons influence growth in different parts of the tree, with buds and branches growing in the spring; the cambium, or trunk, in the summer. Roots grow in both the spring and the fall, which is why these are the best times of the year to plant a tree!

How roots grow

Roots grow in length and diameter each year in order to take full advantage of the water and nutrients in soil. They also form lateral, or side, roots. Most roots are within the first foot of soil, so when soil is compacted by heavy machinery or roots are cut or damaged, the growth process can be stunted.

The water and nutrients absorbed by roots are transported upward to the branches and leaves. Through photosynthesis, leaves capture light and use the water and nutrients to create food for the tree. Some of the food is used for growth and maintenance of existing tissues, while any surplus is stored for use later, such as during the winter. Because of its central role in supplying food to the tree, the health of the root system will affect the way the rest of the tree grows.

How buds grow

As buds grow, they form branches. You can monitor how fast a tree is growing by looking at the previous year's growth. First, start at the tip of the branch and look along it toward the trunk, until you locate the bud scale scar. This is the end of last year's growth, and looks like concentric lines around the circumference of the branch. Then continue to trace the branch back to the trunk, or to the larger branch it's connected to, and you'll find several bud scale scars. When these scars are close together (within a couple inches), it means the tree is now growing fast and may be stressed.

So if you hang a bird feeder on a branch, will it grow out of reach as the tree matures? The answer is no, because once a tree branch is formed, it stays at the same height, but continues to grow longer and wider. Branches will also increase in diameter, so be sure to monitor anything fastened to or hanging on a tree branch. As a tree branch continues to grow, the string of your bird feeder will "girdle" it, restricting the flow of water and nutrients.

Have you ever wondered what to do with the sprouts, or branches, along the trunk of a tree? When the tree's canopy has been damaged, these sprout from latent or dormant buds that exist under the bark of tree trunk. Also called epicormic suckers, they are the tree's attempt to make sugars for the tree. Certain species are more susceptible to suckers, they may also form on a tree that is overpruned. Typically, you should not remove all the sprouts on a tree, especially if it has been recently pruned and is a mature tree. The tree is trying to tell you it needs more leaves to help it create and store food.

How trunks grow

A tree trunk's growth is measured in diameter, with annual growth in rings. When a tree is cut down, you can count the annual growth rings in order to measure the tree's age. If the growing season had ideal rain and conditions, you may find wider rings, indicating greater diameter growth. In drought years, rings may be very slim, indicating slower diameter growth.

Underneath the bark is the cambium, a tissue associated with diameter growth in tree branches, trunks and roots. Because this living layer is a sheath just underneath the bark throughout the tree, it can be easily be damaged by objects, such as lawn mowers, knocking into the trunk. To protect tree health and promote growth, avoid damaging the cambium.

Summary

If you keep in mind how trees grow, and monitor your own trees, you'll have a better shot at detecting a problem in your tree before it's too late. ∞

Using technology to stay informed about your city: video, MyMinnetonka, RSS, and more!

IN THE JULY 2008 Minnetonka Memo, it was announced that several new technology tools have been introduced that allow residents to be better informed about city projects, meetings, events and news.

If you haven't already, visit *www. eminnetonka.com* and check out the live and on-demand online videostreaming feature. You can watch city council and planning commission meetings live via computer from wherever you are, or access past meetings and jump right to the point in the meeting you'd like to watch. Not sure at which meeting an issue was discussed? Use the search function provided to locate exactly what you're looking for, then watch it!

Another way to stay updated on what's happening in the city is to sign up for a MyMinnetonka account. You get to choose what types of updates you want to receive, and when that information is updated on *www.eminnetonka.com*, it will be immediately delivered to your email inbox. Options include:

• City news

Receive each news item as a separate email the moment it is posted on the site, or receive digest emails with summaries of the previous day's news items.

• Jobs

Choose what type of job notifications you'd like to receive, including full-time jobs, part-time jobs, summer publicworks/natural resources jobs, and recreation jobs (summer, seasonal, and year-round).

• Meetings

Email notifications are available for the city council and all of the boards and

commissions, such as the planning commission, park board, and economic development authority. Meeting notices, agenda packets, minutes, and links to videos of the meetings will all be sent straight to your inbox.

• Projects

Want to receive a notice whenever a new project is being considered by the city? Just sign up! You can also sign up for notices on individual projects, which can include project updates, staff reports, meeting notices and outcomes, newsletters, links to video of the discussion of the project in a meeting, and more!

Through MyMinnetonka, you can also provide feedback on projects during the public comment period—your comments will be incorporated into staff reports for consideration by the planning commission or city council. If you have an account, all you need to do is login to provide feedback; otherwise, you can provide feedback with just your name and address. Either way, you can choose whether your address will appear along with your feedback in the staff reports. Feeds, sometimes called RSS, are another great way to receive up-to-the-minute project, meeting, news updates, and job notices from

the city. Many feed readers are available, and current versions of most web browsers typically have built-in feed readers.

Detailed information for using the MyMinnetonka system, including a video tutorial, and instructions on setting up feeds, are available at *www.eminnetonka.com* under "Top Picks."

Also available is the *Hot Topics* e-newsletter, a compendium of city news sent out via email each Friday to subscribers.

You can also subscribe to the online versions of the *Minnetonka Memo*, the city's monthly newsletter, and the *Minnetonka Script*, sent out each month by Minnetonka Senior Services. Both are available as a PDF, and with the *Memo*, all the articles are also posted online each month as news items. The online version of the *Memo* provides handy links to the resources mentioned in each article.

An update on the Southwest LRT

IN EARLY 2007, THE HENNEPIN COUNTY Regional Railroad Authority (HCRRA) completed an alternatives analysis study for light rail transit (LRT) in the southwest metropolitan area, which concluded that light rail is feasible and that several alignment alternatives should move forward for further study.

The next phase of study is about to begin and now is the time to join the conversation about the proposed LRT line, which would serve Minnetonka, Eden Prairie, Edina, Hopkins, St. Louis Park, and Minneapolis. As part of the Draft Environmental Impact Statement phase, the HCRRA will be hosting meetings to give the public an opportunity to review and comment on the three LRT routes under consideration. The meetings are tentatively planned for late September, but meeting dates have not yet been formalized.

Additionally, the city and the HCRRA are just beginning a separate study to look at land uses around the proposed station areas, including the Opus Business Park and in the southeast corner of the Shady Oak Road and Excelsior Boulevard intersection. As this study moves forward, there will be opportunities for public input.

If you have buckthorn on your property, plan to attend "Managing Woodlands: Buckthorn and Beyond," presented by Janet Van Sloun Larson, city of Minnetonka natural resource specialist, Thursday, Sept. 25, from 6:30 to 8:30 p.m. in the community room at the Minnetonka Community Center, 14600 Minnetonka Boulevard, Minnetonka. - Why gradual, prioritized removal is usually much better for a garlic mustard site than an "understory clear-cut" if garlic mustard is present.

Minnetonka residents may drop off the materials listed below. The charge for dropping off each item, if any, is listed in parentheses.

• Air conditioner or water softener (\$20)

Appliances (\$12 each)

Washer, dryer, dishwasher, stove, oven, cooktop, microwave, freezer, refrigerator, water heater, home furnace, trash compactor, garbage disposer, humidifier, dehumidifier.

Batteries (No charge)

All car, truck, motorcycle, ATV, snowmobile and garden tractor batteries are accepted, as well as household batteries (D, C, AA, AAA, 6- and 9-volt cells, button batteries and rechargeable batteries).

- Carpet & padding (\$1/sq. yd. for carpet and \$1/sq. yd. for padding) Determine the number of square yards of carpet or room size the carpet came from. Roll carpet or pad and tape or tie rolls. Rolls must not exceed six feet in length and 12 inches in diameter.
- Copier or fax machine (\$15)
- Electronics (\$1 for any item, including TVs up to 32"; \$5 for TVs larger than 32") TV, stereo console, computer, printer, monitor, radio, small appliance, vacuum, or VCR.
- Fluorescent lamps (No charge) Up to ten fluorescent lamps will be accepted per vehicle. Do not tape lamps together. No lamps will be accepted from business or commercial use. Please transport lamps in a manner to avoid breakage.
- Furniture: Chairs (\$5 small, \$10 large); loveseat (\$15); couch/sofa (\$20); hide-a-bed (\$30); sectionals, dressers, chests, tables and other furniture (\$5 and up depending on size)
- Lumber (\$2 minimum, based on \$25 per cubic yard) No railroad ties or concrete.
- Mattresses and box springs: Single or twin size (\$8 per piece); double, queen or king (\$12 per piece)
- Propane tanks: Small (\$1); Two-pound tank or larger (\$5)

- Scrap metal clean (no charge) Clean scrap metal means all plastic, rubber, wood, concrete and hazardous materials must be removed. Clean scrap metal includes pipe, gutters, swing sets, barbecues, ducting, fencing, etc.
- Scrap metal dirty (\$5)

For example, bikes with tires, lawn chairs with webbing, barbecues or lawn mower with wheels and/or non-metal parts still attached. All engines must be drained of oil and gas. Additional charges apply for riding mowers, garden tractors, snow blowers, trailers, or other large items.

- Tires: Car, trailer or light truck (\$3 each); tires on rim (\$5); tractor or truck tire on split rim (\$20)
- Toilets and non-metal sinks (\$5 each)
- Windows/doors (\$2 minimum, based on \$25/cubic yd.)

Payment will be accepted in cash or local checks payable to the city of Minnetonka.

NO GARBAGE OR HOUSEHOLD HAZARDOUS **WASTE WILL BE ACCEPTED**.

Please note: There will **not** be a charitable organization at the Special Drop-off accepting clothing and household goods.

Brush drop-off open through Nov. 22

Branches up to 12" in diameter will be accepted. Please secure your load during transport, do not drag branches on the road and do not cover the taillights. Proof of Minnetonka residency (driver's license or utility bill) is required to drop off brush.

Please note: trash, metal, concrete, lumber, fences, or wood scraps are not accepted. DO NOT bring these materials with your load of brush. DO NOT put grass, weeds, loose leaves, dirt, sod or other non woody materials in with the brush pile. Find the appropriate disposal option for the unacceptable items. No brush will be accepted from commercial tree or lawn services.

Year-round HHW drop-off sites

Residents may bring household hazardous waste (HHW) to either of Hennepin County's permanent drop-off facilities:

1400 W. 96th St., Bloomington 8100 Jefferson Hwy., Brooklyn Park

There is no charge to drop off residential HHW.

Facilities are open Tuesdays, Thursdays and Fridays, 10 a.m. to 6 p.m.; Wednesdays, 10 a.m. to 8 p.m.; and Saturdays, 8 a.m. to 5 p.m. Facilities are closed Sundays, Mondays, Independence Day, Thanksgiving, Christmas and New Year's Day.

The HHW drop-off is open to any Hennepin County resident and only accepts items from households. No hazardous waste or problem materials can be accepted from business, including home businesses or non-profit organizations.

As of March 1, 2006, there is a limit to the annual quantities of materials dropped off or picked up. For more information visit *www.hennepin.us* or call Hennepin County at (612) 348-3777.

Labor Day delays recycling collection

The Sept. 1 Labor Day holiday will delay recycling collection in Minnetonka by one day. Residents west of I-494 will have recycling collection Tuesday, Sept. 2, while residents east of I-494 will have recycling collection Wednesday, Sept. 3.



Household hazardous waste includes

such items as paint, stain, thinners, solvents, pesticides, herbicides, cleaners, gasoline, used oil, oil filters, aerosol cans, fire extinguishers, fluorescent and HID lamps, thermostats, switches and thermometers containing mercury, rechargeable appliances and batteries.

Also accepted for no charge are consumer electronics (TVs, radios, stereos, VCRs, camcorders, telephones, computers, monitors and printers).

Household appliances (microwaves, water heater, stove, freezer, washer, dryer, etc.) may be dropped off for a \$15 fee.


Minimum charge for loads of junk (only at Brooklyn Park site) is \$16. The fee and acceptable materials are determined by Hennepin County staff. **Checks or cash only.**

Sign up for organics recycling today!

Last year, Minnetonka received a Waste Abatement Incentive Grant from Hennepin County to encourage residential refuse haulers to offer organics collection to their customers.

Since the program was announced, hundreds of families have signed up for weekly collection of organics, diverting many tons of organic materials. Organics make up about 25 percent of the residential waste stream. Collecting this material for composting keeps it from being incinerated or dumped into landfills. It is a valuable resource used in landscaping and road construction projects.

Organics collection includes the following materials: food scraps (fruits and vegetables, meat, fish and bones, bread, pasta and baked goods, egg shells, dairy products and coffee grounds), food-soiled paper products (paper towels and napkins, paper plates and cups, milk and juice cartons, pizza boxes, egg cartons, packaging from frozen and refrigerated foods,

waxed paper and paper containers, coffee filter and tea bags), and other compostable items (full vacuum cleaner bags, dryer lint, tissue and cotton balls, floral trimmings and house plants).

There is an additional fee for the weekly organics collection. However, with weekly organics collection, many homes will be able to reduce their garbage collection to the smallest container the company offers. For further savings, some haulers offer every-other-week collection of the garbage!
