# Planning a home project? Ask the pros!



# Keeping deer away from nature's salad bar

MINNETONKA RESIDENTS ARE WELL AWARE OF THE CITY'S substantial deer population, and those deer find native wildflowers, small trees, and shrubs quite tasty. While deer munch on the woody plants from above, rodents are nibbling on the bark and cambium from below. Animal browsing makes plant re-establishment a challenge in city restoration projects.

Now that many acres in the Minnetonka Park system have had buckthorn and other invasive plant species removed, a test plot study has been established to monitor the ability of selected native plants to become re-established in areas previously occupied by

non-native, invasive plants.

In 2006 five native shrub species indigenous to the oak woodlands of Minnetonka were planted in the test plots. Bare root and potted nannyberry, gray dogwood, choke cherry, hazelnut, and pagoda dogwood were planted in 80 percent of the plots. The other 20 percent of



plots had no plantings, so that natural regeneration can be observed. To protect these native species while they regenerate, 20 deer exclosures have been built in three natural-area parks: Lone Lake, Big Willow, and Victoria-Evergreen. A deer exclosure is just the opposite of an enclosure — designed to keep the deer out rather than in. These structures are 900 square feet, constructed with posts and fenced with synthetic black mesh. For every four deer exclosures, one open plot exists to allow comparison of plantings inside and outside of protected areas.

Because the deer threat in Minnetonka isn't going away, plants inside and outside of the deer exclosures will be observed for many years. However, replanting in parks will not wait for years — as funding and volunteer time allow, new native plantings will be installed in active restoration areas. A variety of plant-protection materials will be used around the new plants, including fencing rings, hardware cloth, and tube tree shelters.

### More about native plant revegetation

- Native plant populations have dropped to an alarmingly low level in the understory of most suburban parks, and have nearly disappeared from many others.
- In addition to munching on garden and woodland plants, deer also rub the velvet from their antlers on sapling trees, causing damage to the vascular systems directly under the bark and sometime killing the tree.
- Ten re-vegetation plots have been set up at both Big Willow and Lone Lake parks, while Victoria-Evergreen has five plots. Twenty of these plots are fenced exclosures.
- Plot locations within the parks were chosen to take advantage of as many site variations as possible. Tree canopy type and density, ground slope, directional exposure, and ground cover composition differ on each site.

# Prepare for winter driving

TRAFFIC CRASHES CLAIMED 475 LIVES IN MINNESOTA LAST year. During the winter, hazardous driving conditions increase the risk of a crash. In addition to basic safety habits such as buckling up, driving sober and traveling at a safe speed, drivers should take special winter precautions so small mistakes don't turn into serious problems.

#### Start smart

If your car has been outside during a snowfall, brush off all the snow before setting out. Snow left on the front hood will blow into the front vent and cause defrosting problems. It can also melt and re-freeze on the windshield. Snow on the roof will cover the rear window and snow on the rear deck will blow onto tail lights. Pay particular attention to cleaning off headlights and tail lights so other motorists can see you.

#### **Drive safely**

Adjust your speed to the conditions and increase the distance from vehicles you are following. Remember that bridges, overpasses, and ramps can be more slippery than other parts of the road. If you begin to skid, remain calm, ease your foot off the gas, and turn the wheel in the direction you want the car to go. If you have an antilock braking system (ABS), apply a steady firm pressure to the brake pedal. Never pump ABS brakes.

#### Plan for problems

If you find yourself stranded even after following all precautions, stay calm and stay put. Your chances of being rescued are greater if you remain in



one place. Staying in your car will decrease your risk of frostbite or hypothermia. Run your engine for heat about once an hour — every half-hour in extreme cold. Make sure your exhaust pipe is clear to prevent the back up of carbon monoxide. Leave one window slightly open. Tie a piece of brightly colored cloth to your antenna to alert others and aid rescuers. Last, but not least, always have supplies on hand to see you through an emergency. Store the following supplies in a metal bucket or coffee can:

- Small candle with matches or disposable lighter
- · A brightly colored cloth, such as a bandana
- · Basic first-aid kit
- A large plastic garbage bag to insulate feet, legs and torso
- High-energy, non-perishable foods and bottled water ∞

# Residents invited to learn more about I and I Feb. 20

As FIRST REPORTED LAST FALL, THE CITY OF MINNETONKA IS launching a five-year effort to reduce the flow of clear water into the Met Council's overburdened sanitary sewer and waste treatment systems.

The cause of the problem is the flow of clear water such as rain water or groundwater into the sanitary sewer system — commonly called inflow and infiltration or I and I. During major rain events, this additional surge of water can consume the capacity of sewer pipes, resulting in home backups and overflows into creeks, wetlands and rivers.

The inflow portion of this problem generally can be traced to sump pumps, roof leaders and foundation drains that have been connected to the sanitary sewer system. For example, a sump pump may be connected to the sanitary sewer system via a hose leading from the pump to a laundry tub or floor drain. Foundation drains may be connected to a home's sewer service outside, without the knowledge of the homeowner.


To assist homeowners in identifying problematic connections, the city will begin home inspections in March in the areas of the city identified as having increased sewer flow after rain events (highlighted on the map below).


If a homeowner is found to have illegal discharge into the sanitary sewer system, the city is providing a matching grant program to assist homeowners in making repairs.

Along with the I and I inspection, each homeowner will receive a new water meter that features automated reading via radio signal. This allows staff to drive through neighborhoods to check meters rather than stopping at each home to record the meter reading. This will provide residents more timely information on water use and possible leaks in the home, if needed.

All inspections and water meter installations will be conducted by SL-serco company, not by city inspectors. The only tasks of these outside contractors will be to conduct the I and I inspection and to install a new water meter.

Residents in the first three areas slated for inspection will be receiving notification via mail of the inspection and meter installation details.





In addition, residents are invited to attend an informational meeting Tuesday, Feb. 20, from 5 to 7 p.m. at the Minnetonka Community Center, 14600 Minnetonka Blvd., Minnetonka.

# Don't be a drip help give I and I the boot!

CITIES ARE BEING ASKED TO REDUCE INFLOW AND infiltration because the Met Council estimates it would cost the region a minimum of \$900 million to build the infrastructure just to process the excess flows at wastewater treatment plants. Costs to expand treatment plants are also prohibitive due to the lack of available building space. And remember—this excess flow is clear water, which doesn't even need to be treated as wastewater.

So, why should you care?

First, I and I may affect your home—clear water reduces capacity in the regional wastewater collection and treatment system and, during heavy rainfall, may cause sewer backups and overflows.

Second, if not addressed, I and I will affect the city's budget. The Met Council has identified Minnetonka as a major contributor to the I and I problem — and under a currently proposed surcharge system, Minnetonka would be charged an additional \$400,000 annually to treat the city's waste.

The good news is the city has five years to correct the problem. During that time, the city can use the money it would have paid in surcharges to implement an education, inspection and repair program designed to reduce the I and I problem. This includes home inspections to identify improper connections to the sanitary sewer system and funding a matching grant program to assist homeowners with necessary repairs.


