Below are answers to the questions most frequently asked by voters. For more specific or current information about these topics, call Minnetonka City Hall at (952) 939-8200 or visit the city's Web site at *www.eminnetonka.com* (click on "Election 2006").

What's the purpose of the primary election?

The primary election determines the candidate from each party who will advance to the Tuesday, Nov. 7, general election. Voters may only vote for candidates within one party.

What are the hours to vote, and where do I vote?

Polling places will open at 7 a.m. Tuesday, Sept. 12, and remain open until 8 p.m. If you are in line at 8 p.m., you will be allowed to vote.

Please see the map accompanying this article for a general idea of your polling place. To find your specific polling place, visit www.eminnetonka.com and click on "Election 2006." Then click on "Polling Place Finder."

Voters may only vote in person at their assigned polling place. Be sure to know your correct polling place — it will save you time.


2007 budget input requested

EW OPPORTUNITIES WILL BE AVAILABLE this year for residents to provide input as the city's 2007 budget is being developed. The city hopes to engage more residents and businesses through several public sessions and greater use of its Web site.

While the city of Minnetonka has always encouraged public input at the staterequired Truth-in-Taxation meeting, this public hearing occurs late in the budget process. This year, three sessions will be held in October to provide interested citizens the

opportunity to learn more about the city's budget and property tax system, and also to ask questions and provide input.

Residents and businesses will also have an opportunity to provide feedback on budget plans via the city's Web site at www.eminnetonka.com. Preliminary budget information will be made available for comment, and that feedback will be shared with the city council as they discuss budget options. ∾

Who can vote absentee?

Absentee voting is available if you cannot get to the

polling place on Election Day due to absence from the precinct; illness or disability; religious observance; or service as an election judge in another precinct.

How do I vote absentee?

Two options are available for voting absentee:

- In person at Minnetonka City Hall during regular business hours, 8 a.m. to 4:30 p.m., Monday through Friday. Extended absentee voting hours also will be available Saturday, Sept. 9, from 10 a.m. to 3 p.m. and Monday, Sept. 11, until 5 p.m.
- By mail by requesting an absentee ballot application at *www.eminnetonka.com* or by phone at (952) 939-8200. Upon receipt of your completed application, a ballot will be mailed. Remember, the voted ballot must be received at city hall by Election Day for the vote to count. Please allow sufficient time for postal delivery.

Can I register to vote on Election Day?

Minnesota allows voters to register to vote at the polls on Election Day. You will need to register if you have never registered to vote; if you have changed your name or address (including just moving to another apartment in the same building) since you last voted; or if you have not voted in four years.

What identification is needed to register?

Minnesota state law requires specific forms of identification to register at the polling place. For more information about these forms, see tables A and B. A person registered in your precinct who knows you can also vouch for you on election day.

Where will election results be available?

Results will be available on cable channel 16, and on the city's Web site.

What is the city's role in the election?

The city plays a key role in the election process. City staff recruits and trains election judges; provides polling place supplies; answers questions; and ensures voter results are tabulated. This process works smoothly because Minnetonka has excellent and dedicated election judges.

What ID do you need to vote?

Voters registering to vote on Election Day must provide proof of residence. You may show **one** item from Table A or **two** items from Table B (valid photo ID plus valid utility bill)

On Election Day you must have one of the following:

- Valid Minnesota driver's license or learner's permit (or receipt for either) showing current name and address in the precinct.
- Valid Minnesota identification card (or receipt) showing current name and address in the precinct.
- Tribal ID showing current name and address in precinct.
- A voucher card signed by the person vouching for the voter and witnessed by an election judge. A voucher is the oath of a voter registered in the precinct who can verify the registrant's address in the precinct.
 - The voucher must have personal knowledge of the person for whom they are vouching.
 - The voucher card must be placed with the registration card.
 - A voter who is vouched for **cannot** vouch for another voter at this election.
 - Challengers **cannot** serve as vouchers.
 - A voucher may vouch for an unlimited number of persons.
 - Voucher **must** leave the polling place as soon as the vouching process is complete.
- Late notice sent from the Elections Office. Place this notice with the registration application.
- Prior registration in the same precinct—voter's former address listed in the polling place roster.
- Current students
 - Student ID or dated registration or fee statement with valid address in the precinct; or student ID if on a dorm list provided by Election Headquarters.

On Election Day voters may register by a combination of one picture ID from Column 1 along with one type of utility bill from Column 2.

Column 1

Approved photo IDs must contain voter's name and photo. It may contain voter's old address or have no address.

- MN driver's license
- MN state ID
- U.S. passport
- U.S. military ID
- Student ID from MN postsecondary school
- Tribal ID

Column 2

Approved utility bills must contain name, current address in the precinct, and date due within 30 days before/after Election Day.

Minnetonka's wastewater collection system under scrutiny

MINNETONKA, OFTEN ON THE forefront of environmentally friendly actions, now finds itself facing another challenge—reducing its flow of clear water into the Met Council's overburdened sanitary sewer collection system.

The cause of the problem is the flow of clear water such as rain water or groundwater into the sanitary sewer system — commonly called inflow and infiltration or I and I. During major rain events, this additional surge of water can consume the capacity of sewer pipes, resulting in home backups and overflows into creeks and wetlands in addition to the Mississippi River.

A flow study completed in 2005 identified a number of areas in the community that contribute to the problem. To encourage communities to address this issue, the Met Council is implementing a surcharge for the excess flow. Under the currently proposed surcharge system, Minnetonka will be charged about \$377,000 annually to treat the city's waste.

That's the bad news.

The good news is the city has five years to correct the problem. During that time, the city can use the money it would have paid in surcharges to implement an education, inspection and repair program designed to reduce the I and I problem. This will include home inspections to identify sump pumps and foundation drains that might be incorrectly connected to the sanitary sewer system. The city is developing a grant program that will assist home owners with the costs of repairs if corrections need to be made. In addition, a thorough inspection of the city's manholes by a consultant engineering firm has already begun, to be followed by inspection of sewer lines and lateral connections.

At the same time, residents will receive new water meters which will allow for automatic reading of the meter and can provide residents with more timely information on water use.

What is inflow and infiltration?

Inflow is a direct connection of clear water into the wastewater collection system, while infiltration is an indirect connection of clear water to the wastewater system.

Inflow is usually traced to sump pumps (used by many homeowners to keep groundwater out of basements), roof downspouts, and foundation drains that are connected to the city's sanitary sewer system. Sumps pumps are often connected to the sanitary sewer system via a hose leading from the sump to a laundry tub or a floor drain.

Infiltration results from groundwater seeping into cracked sewer lines, manholes or deteriorating lateral connections, and requires sealing of the wastewater collection system.

Clear water reduces capacity in the regional wastewater collection and treatment system and, during heavy rainfall, can cause sewer backups and overflows.

Why are cities being asked to reduce inflow and infiltration? Because the Met Council estimates it would cost the region a minimum of \$900 million to build the infrastructure just to convey the excess flows to wastewater treatment plants. Costs to expand treatment plants are also prohibitive due to the lack of available building space.

Special one-day drop-off

Minnetonka residents may drop off the materials listed below. The charge for dropping off each item, if any, is listed in parentheses.

• Air conditioner or water softener (\$20)

• Appliances (\$12 each)

Washer, dryer, dishwasher, stove, oven, cooktop, microwave, freezer, refrigerator, water heater, home furnace, trash compactor, garbage disposer, humidifier, dehumidifier.

Batteries (No charge)

All car, truck, motorcycle, ATV, snowmobile and garden tractor batteries are accepted, as well as household batteries (D, C, AA, AAA, 6- and 9-volt cells, button batteries and rechargeable batteries).

- Carpet & padding (\$1/sq. yd. for carpet and \$1/sq. yd. for padding) Determine the square yards of carpet or size of the room the carpet came from. Roll carpet and tape or tie rolls. Rolls of carpet must not exceed six feet in length or 12 inches in diameter.
- Copier or fax machine (\$35)
- Electronics (There is a charge for consumer electronics: \$1 — any item, including TVs up to 32"; \$5 — TVs larger than 32") Television, stereo console, computer, printer, monitor, radio, or VCR.
- Fluorescent lamps (No charge) Up to ten fluorescent lamps will be accepted per vehicle. No lamps will be accepted from businesses. Please transport lamps in a manner to avoid breakage. Do not tape lamps.
- Furniture: Chairs (\$5 small, \$10 large); loveseat (\$15); couch/sofa (\$20); hide-a-bed (\$30); sectionals, dressers, chests, tables and other furniture (\$5 and up depending on size)
- Lumber (\$2 minimum, based on \$25 per cubic yard) No railroad ties or concrete.
- Mattresses and box springs: Single or twin size (\$8 per piece); double, queen or king (\$12 per piece)
- Propane tanks: Small (\$1); Large over a two-pound tank (\$6)
- Scrap metal clean (no charge) Clean scrap metal means all plastic, rubber, wood, concrete and hazardous

materials must be removed. Clean scrap metal includes pipe, gutters, swing sets, barbecues, ducting, fencing, etc.

• Scrap metal — dirty (\$5)

For example, bikes with tires, lawn chair with webbing, barbecues or lawn mower with wheels and/or non-metal parts still attached. All engines must be drained of oil and gas. Additional charges apply for riding mowers, garden tractors, snow blowers or other large items.

- Tires: Car, trailer or light truck (\$3 each); tires on rim (\$5); tractor or truck tire on split rim (\$20)
- Toilets and non-metal sinks (\$5 each)
- Windows/doors (\$2 minimum, based on \$25/cubic yd.)

Payment will be accepted in cash or local checks payable to the city of Minnetonka.

2006 brush drop-off program

The 2006 Minnetonka brush drop-off site, located at Minnetonka Public Works, 11522 Minnetonka Blvd., is open Mondays and Tuesdays, noon to 8 p.m.; and Saturdays, 7 a.m. to 3 p.m. **The brush drop-off site will be closed Monday, Sept. 4, for Labor Day.**

Branches up to 12" in diameter will be accepted. Proof of Minnetonka residency is required.

Please note: trash, metal, concrete, lumber, fences, or wood scraps are not accepted. **Do not** bring these materials with your load of brush. **Do not** put grass, loose leaves, dirt, or sod in with the brush pile. Find the appropriate disposal option for the unacceptable items.

Year-round HHW drop-off sites

Residents may bring household hazardous waste (HHW) to either of Hennepin County's permanent drop-off facilities:

1400 W. 96th St., Bloomington 8100 Jefferson Hwy., Brooklyn Park

There is no charge to drop off residential HHW.

Facilities are open Tuesdays, Thursdays and Fridays, 10 a.m. to 6 p.m.; Wednesdays, 10 a.m. to 8 p.m.; and Saturdays, 8 a.m. to 5 p.m. Facilities are closed Sundays, Mondays, Independence Day, Thanksgiving, Christmas and New Year's Day.

A new policy effective March 1, 2006, limits the annual quantities of materials dropped off or picked up. For more information visit **www.hennepin.us** or call Hennepin County at (612) 348-3777.

Household hazardous waste includes

such items as paint, stain, thinners, solvents, pesticides, herbicides, cleaners, gasoline, used motor oil, oil filters, aerosol cans, fluorescent and HID lamps, thermostats, switches and

thermometers containing mercury, rechargeable appliances and batteries.

Also accepted for no charge are consumer electronics (TVs, radios, stereos, VCRs, camcorders, telephones, computers, monitors and printers).

Household appliances (microwaves, water heater, stove, freezer, washer, dryer, etc.) may be dropped off for a \$15 fee.

Minimum charge for loads of junk (only at Brooklyn Park site) is \$15. The fee and acceptable materials are determined by Hennepin County staff.


Nominate someone you know for a Reflections Award

Fall is the time to fix or establish your lawn

Sod works well for controlling erosion on slopes or other problem areas and results in an instant lawn with relatively few initial weeds. Disadvantages are the high cost and low shade tolerance. On slopes, sod should be installed horizontally then staked or stapled to prevent sliding. Use a roller after laying the sod to ensure good contact with the soil.

Seed allows for a greater selection of grass species that will tolerate different conditions and may provide a healthier lawn; however, it can require more initial effort to establish. Kentucky bluegrass provides a durable lawn in sunny areas, while fine fescues are more suitable for shady areas and require the least maintenance. Perennial ryegrass is suitable for high traffic areas, but requires more maintenance. Annual ryegrass germinates rapidly and can be used to stabilize the soil temporarily, but it will not grow back in the spring.

Choosing seed

Most bags of seed contain a mixture of species, so be sure to check the label and choose the right mix for your yard. The common varieties of bluegrass such as Park, South Dakota Certified, Kenblue and Common require less maintenance than most of the improved varieties. Annual ryegrass is often included in mixes to help control erosion until the perennial grasses are established. Mixes containing more than 10 percent of annual ryegrass should be avoided if you are hoping to establish a permanent lawn. Consider buying a low-mow mix from a seed supplier, which usually contains a mixture of fine fescues and requires less water, usually no fertilizer, and little or no mowing. For reseeding along the street edge, consider using a salttolerant mix. Perennial ryegrass tends to be more salt tolerant than other species, but be sure to use a winter-hardy variety.

Preparing the soil


Before installing sod or seed, prepare the soil. Compacted soil should be tilled. Add peat moss or compost to soil that has too much clay or sand — this will loosen the soil and improve water retention. Add a fresh layer of clean soil in areas affected by years of road or driveway salt. If the topsoil has been removed from construction or grading activity in your yard, consider adding a six- to eight-inch layer of topsoil, tilling some of the topsoil into the existing soil. Avoid tilling or changing the soil level under the dripline of your trees to prevent their eventual loss. Existing lawns with compacted soil should be aerated.

Installing seed

Apply grass seed according to the rate indicated for the mix and rake it lightly into the surface soil, no deeper than onequarter inch. Applying a light layer of straw mulch will help control erosion and retain moisture. Installing an erosion control blanket on slopes will help retain the soil until the grass is established. Hiring a professional to hydroseed your lawn can minimize much of the labor of seeding a new lawn and increase your success rate.

Fertilizing

Before applying fertilizer, test the soil. Many yards already have sufficient nutrients to promote growth. Consider using an organic



fertilizer rather than a starter fertilizer containing phosphorus — organic fertilizers release nutrients slowly to stimulate growth, while also preventing nutrient loss and runoff. Avoid fertilizing fine fescues to prevent development of disease harmful to the grass. Also, mulching instead of collecting grass clippings provides nutrients and reduces the need for fertilizer. Setting the mower blade higher (3" is optimum, but no lower than 2-1/2") results in grass with less need for fertilizer and water and helps prevent weed growth.

Weed control

Now is the time to control broadleaf weeds — pull, dig, cut or spot treat existing weeds rather than using a general herbicide on the entire lawn. Organic weed controls are safer than traditional herbicides and more environmentally friendly. Most herbicides should not be applied to newly seeded lawns.

Watering

Whatever vegetation you choose, it is important to provide adequate water until the root systems have established. It is best to water between 4 a.m. and 8 a.m. to prevent water from evaporating. Avoid watering late in the day or at night keeping your yard wet overnight can encourage diseases harmful to the plants. Be certain to check the city Web site for information regarding watering restrictions.

Lawn alternatives

Give yourself a lawn care break by reducing the amount of turf in your yard. Consider planting a native wildflower garden, grass prairie or shrub woodland. Native vegetation has longer root systems than turf species, allowing for greater water absorption and erosion control. Shortgrass prairie species reduce lawn care while maintaining an open yard. Native trees and shrubs attract desirable wildlife such as songbirds, while discouraging Canada geese. In addition, native plants are more adapted to the local climate and soils and help maintain Minnetonka's regional character. Finally, planting gardens of non-invasive species such as fruit trees, lilacs, hostas and tulips also reduce lawn maintenance.

Treat your trees to a professional arborist

REES ARE AN INVESTMENT, WHICH IS important to keep in mind when hiring an arborist to trim and/or remove trees. Strategically planted trees can save on heating and cooling costs, reduce storm water runoff, attract birds, and add value to your home. If you are a homeowner with trees — and if you live in Minnetonka, chances are that includes you — take a moment to review these tips about hiring a tree care company.

- Think about the health and biology of the tree. Ask if a certified arborist will be overseeing the pruning work. Although the title of certified arborist does not always guarantee high quality, it does indicate a level of professionalism in the tree care industry.
- Think about safety and the risk of potential damage during tree work. The city of Minnetonka does not require tree companies to be licensed to work in the city. Ask for certificates of insurance, including proof of liability for personal and property damage (your property and your neighbor's) and workers' compensation. Then phone the insurance company to make certain the policy is current. Under some circumstances, you can be held financially responsible if an uninsured worker is hurt on your property or damage is done to your neighbor's property!
- Consider where the company is located. Beware of individuals who go door-todoor and offer bargains for performing tree work, especially if they are not based in the metro area. Most reputable companies are too busy to solicit work in this manner. Improper tree care can take many years to correct and may negatively affect the health of the tree or cause it to decline. The city of Minnetonka requires anyone soliciting door-to-door to acquire a permit from the city.

- Get more than one written estimate. Require full details of the work and costs of any additional work that may
 - be necessary. Two or more opinions and written cost estimates are worth your time and efforts. Usually, estimates are free, but expect to pay a fee and always ask before setting the appointment. Never be pressured or rushed into accepting work by apparent bargains. Never pay in advance.
- Ask for local references. Take a look at some and if possible talk to the former client. Experience, education, and a good reputation are signs of a good arborist.
- A good arborist or tree care professional will:
 - Offer a wide range of services, including pruning, removal, fertilizing and others, not just tree removal.
 - Never use climbing spikes on a healthy tree unless it is being removed from the landscape.
 - Never recommend topping a tree. They will only recommend corrective pruning, such as drop-crotch pruning, after severe damage to the crown. Decorative pruning, such as pollarding or espalier, should begin on a young tree and be continued on a regular basis.
 - Never be eager to remove a healthy, living tree. Removal should be the last resort.

Back-to-school safety

A long with packing lunches and organizing backpacks, don't forget to review safety tips with your student before the first day of school! Here are a few reminders:

Riding the bus

Riding a school bus is safer than riding in a car, but even so, last year approximately 26 students were killed and another 9,000 were injured in incidents involving school buses. More often than not, these deaths and injuries occurred as students were entering and exiting the bus. Remember these bus safety tips:

- Wait for the bus away from traffic and the street.
- Stay away from the bus until it comes to a complete stop and the driver signals you to enter.
- When exiting the bus, walk ten giant steps away from the bus. Keep a safe distance between you and the bus. Also, remember the bus driver can see you best when you are a distance away from the bus.
- Use the handrail to enter and exit the bus.
- Be aware of the street traffic around you. Drivers are required to follow certain rules of the road concerning school buses, but not all do. Protect yourself and watch out!

Walking and Biking to School:

Young pedestrians face a wide variety of decisionmaking situations and dangers while walking to and from school. Here are a few tips to smooth the way:

- Walk with a buddy.
- Obey all traffic signals and/or the crossing guard. Never cross the street against a light, even if you don't see any traffic coming.
- Walk your bike through intersections.
- Wear reflective material or bright clothing, which makes you more visible to street traffic.

Riding in a car

You might have heard that most traffic crashes occur close to home—and it's true.

- Passengers are four times more likely to be seriously injured or killed if ejected from the vehicle in a crash. Safety belts lower your risk of injury by 45 percent and are the best form of protection you have in a crash.
- Everyone needs to be buckled up properly. That means older kids in seat belts, younger kids in booster seats and small children in child safety seats. The Minnetonka Police Department provides free car seat safety checks call (952) 939-8500 to schedule an appointment.



MVST question on the November ballot

T THE NOVEMBER 7 GENERAL ELECTION, Minnesotans will have the opportunity to vote on a constitutional amendment to dedicate all of the revenue from the existing motor vehicle sales tax (MVST) to highway and transit improvements. Currently, only 54 percent of the MVST revenue is used for transportation purposes. Passage of the amendment would provide another \$300 million per year for highway and transit systems throughout the state.

In Minnesota, passing an amendment to the constitution requires a majority vote of all people voting. If a voter leaves this question blank on the ballot, that is considered a "no" vote. For more information on the proposed amendment, see: www.voteyesmn.org ∾
