

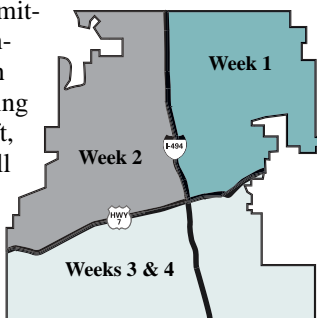

## Information offered on solicitors, peddlers

**S**PRING OFTEN BRINGS an increase in door-to-door sales and soliciting. Individuals representing for-profit organizations that sell products or services require a license from the city. Licensed peddlers and solicitors will also wear a photo ID issued by the city. The city does not endorse any specific product or service by issuing this license.

Charitable organizations conducting door-to-door sales or solicitations do not

need a license, unless they pay their solicitors. However, the city requests that charitable organizations register.

Every resident and business has the right to prohibit peddlers and solicitors from their property. If you post a sign on your home or business that prohibits them, peddlers or solicitors are not permitted to approach your property. If you have a complaint about any person conducting door-to-door sales or soliciting, please contact the Minnetonka Police Department immediately, (952) 939-8510 or 9-1-1. □

# ATTENTION, PARENTS!

**1. WHAT IS CONTRIBUTING TO THE DELINQUENCY OF A MINOR?** It is a gross misdemeanor for any person to in any way encourage, cause or contribute to the delinquency or deprivation of any minor (Minnesota Statute 260B.425). Providing alcohol or drugs would be construed as contributing to the delinquency of a minor.

**2. WHAT ARE THE LEGAL CONSEQUENCES FOR CONTRIBUTING TO THE DELINQUENCY OF A MINOR?** There are both criminal and civil legal consequences that can result from contributing to the delinquency of a minor by providing the minor with alcohol or other drugs.

**3. WHAT ARE THE CRIMINAL LEGAL CONSEQUENCES?** Contributing is considered a gross misdemeanor which carries a maximum penalty of one year in jail, \$3000 fine, or both.

**4. WHAT ARE THE CIVIL LEGAL CONSEQUENCES?** A lawsuit could be filed against the adult who provided the alcohol or drugs if any injury should occur. An example would be a minor who acquires the alcohol in your house and then injures or kills someone else in a car accident. The resulting civil lawsuit could be for damages limited only by the mood of the jury.

**5. WHAT IS THE DRAM SHOP LAW?** This law was enacted to make liable any person who knowingly supplies alcoholic beverages to anyone under 21, or to an intoxicated person. The law applies to individuals and businesses.

**6. WHAT IS SOCIAL HOST LIABILITY?** Social host liability is an extension of the Dram Shop law which stipulates that a person serving or supplying alcohol to a minor is liable for damages in a civil lawsuit. In one lawsuit, a neighbor who served as bartender for a graduation party was held liable in addition to the parent.

**7. CAN PARENTS OR SOCIAL HOSTS FACE CRIMINAL CHARGES?** Yes, any adult who supplies a minor with alcohol could face charges of contributing, a gross

misdemeanor, which carries a maximum fine of \$3000, one year in jail, or both.

**8. WHAT ARE THE PENALTIES FOR BEVERAGE DEALERS FOR PROVIDING ALCOHOL TO MINORS?** Beverage dealers could have their license suspended or revoked. The person making the sale would face criminal charges for contributing to the delinquency of a minor. If damages or injuries result from the sale, the dealer could be named in any lawsuit.

**9. ARE THERE LIMITS TO THE AMOUNT OF PERSONAL LIABILITY IN A CIVIL LAWSUIT?** The jury could award any amount of damages in a lawsuit. A persuasive lawyer and a case which creates a sympathetic jury could produce awards in the million dollar plus range. Personal assets may not be protected from this judgment.

**10. DOES YOUR HOMEOWNERS' INSURANCE COVER LIABILITY WHEN ALCOHOL IS INVOLVED?** Homeowners' insurance is intended to cover those incidents for which the results were not foreseen or intended. A violation of the law, such as providing alcohol to minors, could eliminate any responsibility on the part of the insurance company.

**11. COULD PARENTS BE HELD LIABLE IF THEIR MINOR CHILD CONSUMES ALCOHOL OBTAINED FROM THEIR HOME?** The parents could be liable in a civil lawsuit. If the parents knowingly and willingly provide the alcohol to the minor, the outcome of the lawsuit would be very predictable. If the parents did not have a locked liquor cabinet and the alcohol was accessible to the minor, the parents probably would be held liable even if it was consumed without their knowledge. The parents could also be liable if their

Dear Parents:

As the end of the school year approaches, there will be many opportunities for your son or daughter to participate in celebrations such as prom and graduation parties. As law enforcement administrators, we care about the safety of your children. We are concerned about the temptations of alcohol use and choices they may have to face. We also know that this is an exciting time for you as parents. It is amazing how one day you can't wait for your child to grow up, and the next day they have.

If you are planning to host a party at your home or other location such as a hotel/motel, carefully consider your responsibilities in doing so. Please remember that selling, furnishing or serving alcohol to minors is a criminal offense in Minnesota. In addition, any adult who knowingly provides alcohol to a minor can be exposed to personal liability for injuries that occur from that minor's intoxication. Please read the following information to further answer any questions you may have about minors and alcohol.

It is important to remember that giving young people lectures or using threats isn't the answer to preventing underage drinking. It takes more than citing the law or simple declarations of your rules to encourage youth to do the right thing. Speaking openly and honestly with one another about issues that really matter is one of the most valuable gifts that families can share.

This is one of the most memorable times for your son or daughter. By the combined efforts of parents, law enforcement agencies, educators, and community leaders, let's work together to "Reduce the Use" and help our young people make the right choices!

minor child provides alcohol to another minor even if they have no knowledge that this was done. Alcohol is a controlled substance and parents need to ensure that this is not readily accessible to minors.

**12. COULD PARENTS BE HELD LIABLE IF THEY RENT A MOTEL ROOM FOR THEIR MINOR CHILD AND ALCOHOL IS CONSUMED THERE?** The parents could be held liable even though they did not know alcohol was being consumed. There is no limit to the amount of damages that could be recovered in a civil lawsuit if some injury should occur in which the minor was at fault.

**13. WHAT RESOURCES ARE AVAILABLE FOR MINORS IN NEED OF HELP WITH ALCOHOL/DRUG PROBLEMS?** There are several local agencies that can provide services or direct you to the appropriate agency. Consult any of the following: school personnel/counselors, school addiction counselors, Native American program office, treatment centers, clergy and church personnel, and law enforcement.

**14. NOT A DROP... KISS YOUR LICENSE GOODBYE IF YOU DRINK A DROP OF ALCOHOL AND DRIVE.** In Minnesota, it's illegal to drink if you're under 21. If you drink and drive, you are not only subject to the state's DWI laws, but you also face penalties under Minnesota's "NOT A DROP" law. Under "NOT A DROP," if an officer observes you operating a motor vehicle and determines you've been drinking, you'll lose your license. For how long? From 30 to 180 days. The length of suspension will depend on your prior record. (MN Statutes 340A.503 and 169.33)

**C**ITY ATTORNEY Desyl Peterson was named winner of the Spirit of Minnetonka award at a recent Minnetonka city employee recognition event. ## Southwest Corridor rail transit study scheduled

**H**ENNEPIN COUNTY AND the cities of Minnetonka, Hopkins, Eden Prairie, St. Louis Park, and Minneapolis have been working together to determine if light rail transit is feasible along the southwest corridor from Minneapolis to Eden Prairie. Recently, recommendations were made that four alignments be moved forward for an Advanced Planning Study. This study will begin late summer and again include open houses and other opportunities for public input. ## Special rates available for seniors

**T**HE CITY OF MINNETONKA has a minimum residential sewer bill based on 15,000 gallons of water usage. However, for individuals over the age of 62 who homestead their property, this minimum does not apply. Under the senior rate, you pay only for your exact usage, based on winter quarter consumption. ## DID YOU KNOW?

**T**he City of Minnetonka has 18 wells and 10 water towers that store 13 million gallons of water. The largest "water tower" is the in-ground reservoir at Tower Hill — it holds 5 million gallons. Last year the city pumped 3+ billion gallons of water from the ground. The average city water hardness is 19 grains.

## Please follow these sign guidelines when advertising your garage sale

**T**HE GARAGE SALE season is about to begin! Please keep in mind the following guidelines regarding garage sale signs:

- Get permission from the underlying property owner(s).
- Place sign at least five feet from the edge of a public street; don't block the view of cars.
- Have only one sign per intersection.
- You may post your sign Thursday through Saturday; please remove immediately after your sale.
- Make your sign less than three square feet in size (1' x 3').

# Spring Leaf Drop-off Program

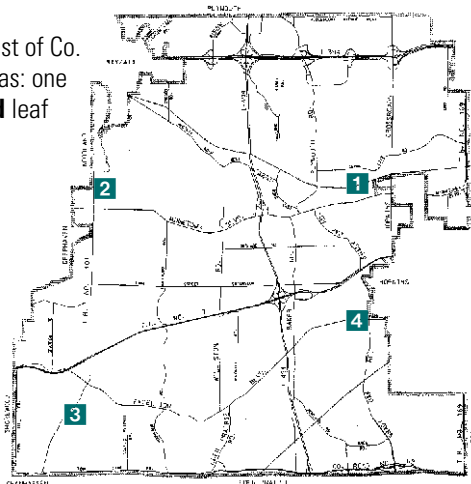
**Saturdays: April 24, May 1, May 8  
10 a.m. – 3 p.m.**

Minnetonka residents may bring *bagged* leaves and yard and garden materials to one of the four drop-off sites shown on the accompanying map on the dates and times listed above. *Brush larger than 1/2" in diameter will not be accepted at the leaf drop-off sites.* (See brush drop-off article at right.)

If you have other means of handling your leaves, such as collection by your garbage hauler or by backyard composting, **please use that option.** All garbage haulers offer curbside collection of yard waste on the same day as garbage collection for a reasonable annual or monthly fee. The garbage hauler yardwaste collection programs typically run mid-April through mid-November. Check with your hauler for details.

## SATURDAY LEAF DROP-OFF SITES

- 1 Public Works Facility Parking Lot**  
(11522 Minnetonka Blvd., 1/4 mile west of Co. Rd. 73) **Use west entrance.** Two areas: one for **bulk** leaf drop-off, one for **bagged** leaf drop-off; follow signs.
- 2 Groveland School Parking Lot**  
(Minnetonka Blvd., east of Hwy. 101)
- 3 Minnetonka Public Schools Service Center North Parking Lot**  
(5621 Hwy. 101)
- 4 West Oaks Community Church Parking Lot**  
(Excelsior Blvd., west of Shady Oak Rd.)



## BAGGED LEAVES accepted at all sites on Saturday dates (4/24, 5/1, 5/8) only.

City staff will assist residents with unloading bags of leaves on Saturdays. Residents will be asked to take empty bags home for re-use or disposal. Loosely tie bags for easy emptying.

## BULK LEAVES (loads of leaves must be covered during transport) – only accepted at the Public Works Facility, 11522 Minnetonka Blvd. on these days and times.

**SATURDAYS:** 7 a.m. to 3 p.m. April 17, April 24, May 1, May 8, May 15, May 22

**MONDAYS:** noon to 8 p.m. April 19, April 26, May 3, May 10, May 17

**TUESDAYS:** noon to 8 p.m. April 20, April 27, May 4, May 11, May 18

Residents will unload their own leaves onto the bulk pile (bring proper equipment to quickly unload your own leaves). Using many layers of tarps between a foot or two of leaves makes unloading your leaves easier and faster. Try it!

## 2003 brush drop-off site opens Saturday, April 17

The 2004 brush drop-off program will begin Saturday, April 17, at the Minnetonka Public Works Facility, 11522 Minnetonka Blvd. The site will be open during the week on **Mondays** and **Tuesdays**, noon to 8 p.m., and on **Saturdays** from 7 a.m. to 3 p.m. through November 20. (The brush drop-off site will be closed Memorial Day, May 31; Independence Day, July 5; Labor Day, September 6.)

Branches up to 6" in diameter will be accepted. A valid Minnetonka I.D. is required to drop off brush. No brush will be accepted from commercial tree or lawn services. No trash, grass, loose leaves, dirt, sod, lumber, fences, or wood scraps are accepted.

Call the Recycling Coordinator, (952) 939-8217, during business hours or leave a message anytime to obtain more information.

## Compost bin sale scheduled

Hennepin County will sell compost bins at the Minnetonka Ice Arena/City Hall parking lot, 14600 Minnetonka Blvd., on Saturday, April 10, from 10 a.m. to 2 p.m. Hennepin County will be subsidizing the cost again this year. For \$30, you may purchase a compost bin, kitchen bucket, and instruction book. There is a limit of one composting kit per household. To reserve your composting kit, register on line at [www.GreenGuardian.com](http://www.GreenGuardian.com), or call (651) 292-3933. Only cash or checks are accepted — no credit cards.

The April 10 distribution event is the first one this spring. There are ten other compost kit distribution events on different days around the metropolitan area. You may go to any event to pick up your composting kit, if you're unable to attend the event on April 10.

## Natural Resource Notes

# Spring cleaning will help protect our lakes, creeks, and wetlands

Our snow is finally melting and the spring rains are here! As the water runs off rooftops, driveways, streets, and parking lots, it carries with it anything that may land on its impervious surface. Items such as cigarette butts, pop bottles, gum wrappers, fertilizer, leaves, grass clippings, pet feces, oils, and solvents pollute and contaminate our water resources.

### Stormwater is a leading cause of water pollution

According to the Environmental Protection Agency, storm water is one of the leading causes of water pollution. Storm water is any water that lands on an impervious or hard surface and drains into the storm drains located in the street. This water is then piped directly to the neighborhood lake, creek, or wetland.

Cigarette butts, pop bottles, and gum wrappers are an eye-

sore and a nuisance. Bacteria and nutrients from pet feces, contaminants from solvents and oil, and high levels of nitrogen and phosphorus from fertilizer, lawn clippings, leaves, and other organic debris cause the direct degradation of our water resources. Phosphorus is the key nutrient responsible for excess algae blooms and nuisance aquatic weed growth. Studies indicate that it only takes one pound of phosphorus to create 300 – 500 pounds of algae.

Algae blooms and nuisance aquatic weeds can literally destroy a lake, creek, or wetland. They prevent the native species from obtaining sunlight. Not only do they help kill our native plant communities, but as they biodegrade, they use all of the oxygen, resulting in fish kills. This is not only a nuisance for local residents, but it affects the animals that depend on these wetland environments.

### Here's how you can help

Property owners can help protect water quality. These simple steps can help make a difference in the quality of our water resources:

- Make sure you are using a zero phosphorous fertilizer.
- Fertilizer, leaves, and grass clippings that may land on driveways and streets should be swept up. If you hire a lawn care company, talk to them to ensure that they are doing this.
- If you live on a wetland or pond, keep a natural buffer of native plants.
- Do not litter. Please pick up any garbage that may be in the street. This includes picking up after your pet.

We must remember that storm water is the community's water, and our individual actions can make a difference. Thank you for helping to protect our water resources. □

## Tips offered on lawn care

WITH CONCERNS ABOUT use of pesticides and herbicides on gardens and lawns, many residents are reducing their use of chemicals and finding alternatives. There are many lawn care companies that now use non-toxic methods. Consider these non-toxic alternatives:

- Create healthy soil. Leave clippings on the lawn. Mulch leaves.
- Water infrequently but deeply to promote deep root growth.
- Mow high, 2–4 inches, to discourage weed growth. Keep mower blade sharp.
- Aerate lawn in spring or fall.
- Pull weeds by hand. After weeding gardens, apply a thick layer of mulch.
- Learn to live with some weeds.

If you do use pesticides, *read the product label*. Follow all precautions. Mix and use only at the recommended strength. Apply only where needed. Don't spray on windy days. Look for synthetic pyrethroid products (instead of organophosphates or carbamates).

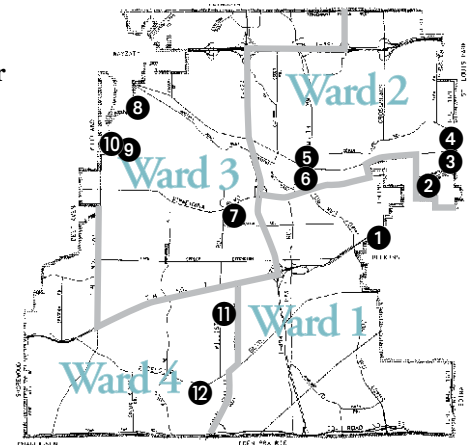
