Panelist Bios:

Bob Lux Alatus, LLC

Bob founded Alatus LLC in 2005 and serves as its Principal. He has been in the real estate development and investment business for over 30 years. He has served previously as a Director of Minnesota Multi-Housing Association, NAIOP, and is an active member of the Minnesota Chapter of Urban Land Institute.

Jeff Washburne has served as the Executive Director of the City of Lakes Community Land Trust since 2002, implementing the community vision of starting a Community Land Trust in Minneapolis. In 2014 he completed the NeighborWorks Achieving Excellence in Community Development Program at Harvard Kennedy School. Jeff currently serves on the boards of the Minneapolis Consortium of Community Developers (MCCD), Land Bank Twin Cities, NorthPoint Health and Wellness Center, MN Cycling Center (MCC), and the MN Community Land Trust Coalition (MNCLTC).
