2019 election results

The 2019 municipal election was held Tuesday, Nov. 5. There were five city council seats on the ballot - all four ward seats and a special election for one atlarge seat. The winner of each seat is:

- Ward 1: Brian Kirk
- Ward 2: Rebecca Schack
- Ward 3: Brad Schaeppi*
- Ward 4: Kissy Coakley
- At-Large Seat B: Susan Carter

*Ward 3 City Council Candidate Mike Happe requested a recount because the margin between candidates was closer than .5 percent. The recount was held after the Minnetonka Memo went to print. Find results on minnetonkamn.gov/news.



The four ward council members will begin four-year terms in January. The at-large special election winner was sworn-in in November and will complete the remainder of the current term, which concludes in December 2021.

2020 budget summary and public hearing



In September, the city council adopted a preliminary property tax increase of no more than 7.76 percent for 2020.

The council will vote on adoption of the final 2020 budget and levy at its Dec. 2 meeting.

What does this mean for the average homeowner?

City property taxes for the median valued home in Minnetonka (\$378,500 for taxes payable in 2020) will increase by approximately \$95* next year.

What's new in 2020?

The proposed 2020 budget includes new bond payments for the police and fire facility improvements; funding to support the fire department's paid-on-call staffing model; a change to ensure the city's compensation structure is competitive in a tight labor market; an additional maintenance position to care for the city's expanding trails and parks and funds to support new sustainability efforts.


*The exact impact on specific properties will depend on the assessed market value of each home. These numbers do not include the proposed increase from other taxing jurisdictions such as the county and school district.

Projected 2020 Revenue


Property taxes make up approximately one-third of the city's expected revenue in 2020.

Get ready for winter snow removal

Please keep the following items in mind as winter weather approaches:

- Plowing operations typically begin between midnight and 4 a.m. (but it can vary).
- Above-average snowfalls may require a multi-day operation to clear (in this order) streets, parking lots, sidewalks, trails and ice rinks.



- Snow removal takes place in three steps: a first pass to provide access, full-width plowing and cleanup.
- Snow cleared from your property must remain on your property. Don't push it into the street or onto sidewalks and trails, and ensure it won't interfere with traffic or plows.
- The city will repair damage to curbs and sod caused by city snowplows. Mailboxes damaged by direct contact with city snowplows will also be repaired. Damage to private improvements (fences, sprinklers, rock gardens, etc.) in the rightof-way are the responsibility of the property owner.
- Place curb markers to show plows the edge of your lawn or driveway. These are available for free at city hall. Try to install before the ground freezes.



- Plowing will result in snow at the end of your driveway. Unfortunately, this is unavoidable and clearing the driveway is the property owner's responsibility. Plows will try to evenly distribute snow in cul-desacs when possible.
- Set garbage and recycling cans behind the curb line so they don't interfere with plows.

Winter parking reminders

- Vehicles can't be parked on a public street between 2 a.m. and 6 a.m., or in one place for more than six hours.
- Parked vehicles and trailers can't interfere with the removal of snow, sleet, slush or ice and may be towed at the owner's expense.

Q: How many fire stations are in Minnetonka?

A: Five. Station 1 is staffed with full-time staff during business hours and 24-7 by our paid on-call duty crew. The other four are not regularly staffed but house gear and equipment to help us respond quickly to emergencies.

Q: How many staff members are full-time?

A: 11 - Fire Chief, Deputy Chief, Assistant Chief of Emergency Management and Planning, Assistant Chief of Fire and Life Safety, Training Chief, Fire Inspector, Training and Recruitment Captain, Operations Technician, two Public Educators and an Administrator.



- **Q:** How many calls did the fire department respond to last year?
- **A:** We responded to 3,621 calls for service in 2018.
- Q: Do you only respond to fires, or other emergencies as well?
- A: In addition to fires, we respond to calls for medical and rescue assistance, hazardous conditions and false alarms. We also provide aid to neighboring communities.



Q: How many fire trucks and other vehicles do you have?

A: We have eight fire engines, one tower truck, two ladder trucks, one air supply truck, three light-duty medical and rescue trucks, two specialty vehicles to fight grass and trail fires, two boats, one water rescue unit and two utility vehicles.

Q: Do you use CPR to save lives often?

A: We saved four lives in 2018 by performing CPR on a patient during cardiac arrest.

Q: Do firefighters work 24-hour shifts?

A: No. Minnetonka Fire is staffed primarily by paid on-call firefighters. They're paid when they train, work shifts and respond to service calls. Each work a minimum of five shifts each month, varying from three to eight hours. Some link several shifts together to work longer shifts.

Q: How often do you hire new firefighters?

A: We hire a new group every year. It takes more than a year to fully train and prepare a new firefighter. We're currently recruiting a new class. Learn more about the Minnetonka Fire Department and apply online at **minnetonkamn.gov/fire.**

Ask a **city planner**

In each issue of the *Minnetonka Memo*, our planners answer a common question to help residents and businesses learn more about the planning process and available city resources.

Question:

How can I determine where my property lines are?

Answer:

Residents often assume their property lines are along the fence, trees or utility lines. This isn't always true. A survey is the most accurate way to locate your property lines. Check with the city to see if we have a survey on file. If not, you can hire a surveyor. If you're applying for a city permit, a survey is required. Learn more at **minnetonkamn.gov/permits**.

The city also has a metal detector loan program to help residents and contractors find property stakes and utility lines. Stop by city hall to borrow a metal detector for 24 hours.

Apply for home improvement and purchasing loans

The City of Minnetonka seeks applicants for a home improvement loan program and another that assists first-time homebuyers.

Minnetonka Home Loan Enhancement program

This program offers low-interest home improvement for Minnetonka residents through the Center for Energy and Environment (CEE). Loan amounts range from \$2,500 to \$15,000 with a 10-year term and a three percent interest rate. Income and asset limits apply.

Welcome to Minnetonka loan program

The city partners with the CEE to offer low-interest loans to assist firsttime homebuyers with down payments and closing costs. Loans are up to \$15,000 with a one percent interest rate and the homebuyer must contribute at least 25 percent of the total down-payment or closing costs; income and asset limits apply.



Plant pest program protects Minnetonka's trees

The city's plant pest program limits the spread of Dutch elm disease (DED), oak wilt and emerald ash borer (EAB) in Minnetonka while preparing for new and emerging threats to our community forest.



Dutch Elm Disease has declined steadily thanks to Minnetonka's strong ordinance that requires removal of diseased elms within 30 days. Sixty-five percent fewer DED trees were marked this year than in 2017.

Oak Wilt frequently occurs in trees with fresh wounds - typically from storm damage or summer pruning - and spreads through shared roots to nearby trees.

Emerald Ash Borer has been confirmed in Minnetonka. Forestry staff scouts the city for early detection. We'll continue to remove small and unhealthy trees in parks and along streets to protect public safety.

Natural resources celebrates volunteers

Volunteers contribute hundreds of hours and endless good-hearted energy to natural resources programs in Minnetonka each year. 2019 project highlights include:

- Arbor Day and Earth Day planting events were held at Victoria-Evergreen Park. Rotary Club members and Gobros.com employees added 20 trees (11 different species) to increase diversity and resilience in this park.
- The Mountain Bike Trail Advocates and Friends of Lone Lake Park cleared buckthorn and assisted with rain garden and prairie maintenance at Lone Lake Park.
- Geocachers volunteered monthly to help natural resources.
- Adopt-a-Spot volunteers maintained specific areas of parkland or monitored wildlife.
- Four wetlands were monitored for the Wetland Health Evaluation Program.
