# Florence Bogle honored with 2020 Reflections Award

Florence Bogle has been a pillar of the Minnetonka community since the very beginning - literally.

Bogle's family moved to Minnetonka in the late 1950s, just after its incorporation into a village. Roughly 10 years later (1968), Minnetonka would officially become a city - and in the six decades since, Florence has done all she can to make Minnetonka a better place.

Bogle's incredible commitment to service and activism has made an immeasurable impact, and it makes her the perfect recipient of the city's Reflections Award, which recognizes individuals, businesses and programs whose outstanding contributions reflect positively on Minnetonka.

"We're honored to select Florence Bogle to receive the Reflections Award," said Minnetonka Mayor Brad Wiersum, who was part of the selection process with the city's former mayors. "It's the least we can do to thank her for a lifetime of service and her immeasurable contributions to our community."

Bogle's daughter Ann nominated her for the award, and described her mother as a leader and a community organizer. "She brought so much talent and grace to everything she did and was very intent to improve the community," Ann said.

Set to turn 90 in April, Bogle has compiled an award-worthy résumé. From 1977 to 1999 she served as director of the ICA Food Shelf and also helped feed the community through the Meals on Wheels program.

As the regional president of the League of Women Voters - an organization she's still in contact with today - Bogle has been committed to ensuring women have a voice in the political process.

"My mom was very keen on the political process, especially local and state elections." said Ann Bogle. "She was very involved."

Bogle's community involvement also includes serving as the Minnetonka Historical Society's longest standing board member, and she's been a steward of Minnetonka's natural environment through

involvement with the Environmental Protection Agency and the Horticulture Society.

"People have an expression, 'Act locally, think globally," Ann Bogle said. "My mom has pretty much always done that. She has a really humble approach. Much of her work [in the community] was unpaid and she found it really fulfilling."

# Vote in the presidential primary March 3

Minnesota's new presidential nomination primary election will be held Tuesday, March 3.

- **Hours:** 7 a.m.-8 p.m. If you're in line at 8 p.m. you're allowed to vote.
- Locations and ballot: Find your polling place and view a sample ballot at pollfinder.sos.state.mn.us.
- Registration: Voters can register at the polls with proper identification. Learn more at minnetonkamn.gov/voters.



- Political party: Voters must select a political party at the polls, and will vote for the candidate they want to represent that party in the November election.
   The party you select will not be tied to your voter registration.
- Vote absentee: Vote prior to Election Day at the Community Center. Visit minnetonkamn.gov/elections for dates, times and details. We'll have extended hours on Saturday, Feb. 29 (10 a.m.-3 p.m.) and Monday, March 2 (8 a.m.-5 p.m.).

In each issue of the Minnetonka Memo, our planners answer a common question to help residents and businesses learn more about the planning process and available city resources.

#### Question:

Why are there colored flags and paint markings in my yard?

#### **Answer:**

Colored flags or paint are used by companies to mark the location of existing utilities ahead of digging or construction. In most cases, you or a contractor you've hired would have requested

utility location from Gopher State One Call before beginning a project on your property.

If your utilities are marked and you didn't request utility location, its likely utility work or road construction



is about to begin on or near your property. To look up who made the request, visit **gopherstateonecall.org** to search for a ticket for your property. Any requests from the last month will be displayed, and you can click on each to learn more.

Always call 811 or visit **gopherstateonecall.org** to request utility location at least 48 hours prior to digging or construction, even for small projects such as real estate signs, mailboxes, planting trees and shrubs or removing a stump.



## Improve the resilience of your lawn

Lawns can be beautiful and functional, but they also require a lot of maintenance that can have environmental side effects. Consider these tips to make your lawn more resilient.



dd perennial plants - such as Dutch white clover, self-heal or wild violet - to the lawn. These low-growing plants provide food for pollinators. Some add nitrogen to the soil, reducing the need for fertilizer.

**ater** less frequently and more deeply. A smart controller allows you to adjust sprinkler runtimes based on moisture conditions, and rain sensors prevent overwatering.

**eutralize** weeds by spot-spraying rather than applying herbicide to the whole yard. Avoid applying any chemicals if rain is forecast to prevent runoff into local water bodies.

**eed** fescue grasses into problem spots where conventional turf doesn't grow well. Fescue grasses perform well in sun or shade. Their long roots hold more water and reduce soil erosion.

## Look for tax notices this month

Residents will receive two notices this month related to property taxes. One is the market value notice from the city, which will affect property taxes to be paid in 2021. The other is the property tax bill for 2020, which is mailed by Hennepin County and must be paid this year.

The city accounts for a little more than 28 percent of a homeowner's total property tax bill. The rest includes taxes for your school district (33 percent), county (33 percent) and other jurisdictions (six percent).

## 2020 market value notice - applies to 2021 property taxes

Property tax in Minnesota is a complicated process governed by state law. Although the City of Minnetonka administers the assessment, Hennepin County and the Minnesota Department of Revenue oversee the process.

The Minnetonka real estate market continues to thrive, with all property types increasing in value.

#### Average 2020 value increases by property type

- Single-family homes 3%
- Townhouses/Condominiums 3%
- Commercial 4%
- Apartments 6%
- Industrial 6%

Keep in mind, individual properties may vary greatly, and adjustments vary by market.

#### How is market value determined?

The city's assessing division maintains records for every property in Minnetonka. Adjustments are made to the market value of most properties based on actual real estate sales of comparable properties from the past year.

At least 20 percent of all properties are physically inspected each year and adjusted based on the results of those inspections. Market value adjustments are also made for building additions, remodeling and other improvements.

## What if I don't agree with my property's market value?

If you have questions or concerns about your property's market value notice or the assessment process, call 952-939-8220. Assessing staff will review property records and sales information with you. Based on the review, the appraiser may or may not make a change to your market value. If not, you have the right to appeal.


## Help is available

## Participate in the 2020 census

Every 10 years, the U.S. Census Bureau counts every person in the United States. Soon, you will receive information in the mail from the census bureau to ensure you and your family are counted.

## How can I participate?

Follow the instructions you receive in the mail to submit your information by mail, phone, in-person or online.

## Why is the census important?

The government uses census data to make important decisions about:

- Distribution of nearly \$900 billion in federal funds.
- U.S. representative seats and district lines.
- State and local government planning.

Census data is also often used by businesses when trying to decide where to build factories, offices or stores.

## Is my information secure?

Yes, the private information you submit is confidential and protected by federal law.

### How can I look out for scams?

The census bureau will never ask for:

- Full social security numbers.
- Money or donations.
- Anything on behalf of political parties.
- Bank or credit card information.
