
City closes all facilities, cancels all meetings and events due to coronavirus

To prioritize the health and well-being of our community, and to help slow the spread of coronavirus, all City of Minnetonka facilities are closed to the public until further notice. All public meetings and city events, classes, lessons and programs are canceled until further notice.

Essential services - including public safety, emergency services and utilities - will continue as usual.

Closed facilities include city hall, public works, the police and fire stations, Williston Fitness Center, Minnetonka Community Center and the Minnetonka Ice Arenas. All non-essential employees who are able are working remotely. Connect with our staff via our website, email and phone.

The city is drafting a new policy that would equip police officers with body-worn cameras. If adopted, the policy and procedure would go into effect in 2021.

Complete the 2020 Census

Every 10 years, the U.S. Census Bureau counts every person in the United States.

By April 1, you will receive information in the mail from the census bureau to ensure you and your family are counted. Follow the instructions to submit your information by mail, phone or online.

Why is the census important?

The government uses census data to make important decisions about distribution of federal funds, representative seats, district lines and state and local planning. Census data is also often used by businesses when deciding where to build factories, offices or stores.

Who should I count?

Everyone should be counted regardless of age, citizenship or permanent residence. If you're completing the census for your household, count everyone living there most of the time as of April 1, 2020.

Smoke alarms and fire drills save lives


Smoke alarms and an escape plan will help your family react quickly in an emergency.

Smoke alarms

Ensure there is a smoke alarm on every level and in every bedroom. Test them often, make sure they're in good working condition and change the batteries regularly.

Escape plan

Develop an escape plan, ensure each family member knows it well and practice it often. We suggest reviewing and practicing it once a month. Your escape plan should be second nature so everyone can react as quickly as possible if there's an emergency.



Street sweeping under way

Minnetonka Public Works will begin street sweeping in late March, weather permitting. For four weeks - or until all streets have been swept - crews will sweep streets in 10hour shifts Monday through Thursday (5 a.m. to 3 p.m.) and in eight-hour shifts on Fridays (5 a.m. to 1 p.m.). Crews try to stay out of residential areas in the early morning, but it is not always possible. In these cases, crews will make every effort to minimize noise.

While the street sweeper does a good job cleaning streets, it can't capture all the debris, so we need your help! As the snow melts, identify the storm sewer grates in your neighborhood, then remove and dispose of the accumulated debris and litter.

Need a loan to help with home improvements?

Housing Rehabilitation Program funds will be available this spring, and the city is now accepting pre-applications. The program offers a limited number of forgivable home improvement loans up to \$15,000 for eligible repairs. Applicants must meet income requirements.

Loans are forgiven if you remain in the home for 10 years, but must be repaid if you sell, transfer the title or no longer live there. In addition to income, eligibility is based on valuation, assets and intended improvements.

Leaf and brush drop-off sites open April 4

Each spring and fall, the city accepts leaves, yard waste and brush from Minnetonka residents at the Public Works facility. Residents must present a driver's license, state ID or Minnetonka utility bill. Commercial tree and lawn services must prove materials came from a Minnetonka address.

The drop-off site will be closed May 25, July 4 and Sept. 7 in observance of holidays.

LEAF DROP-OFF SITE OPEN APRIL 1-MAY 18

Leaf Drop-off Site Guidelines

- Accepted: leaves; yard waste such as grass, weeds, pine cones, needles, straw, plants and garden materials; sticks and branches smaller than one half-inch in diameter
- Not accepted: bags of any kind residents **must** take all bags home, including compostable bags; sod, dirt, trash, concrete, wood; noxious weeds, including garlic mustard and thistle; sticks and branches **larger than one half-inch in diameter** must go to the separate brush drop-off
- Remember to bring proper equipment to unload (i.e. pitchfork, shovel, etc.)
- Items **must** be covered during transport.

BRUSH DROP-OFF SITE OPEN APRIL 4–NOV. 21

- Accepted: trees and branches up to eight feet in length (no diameter restrictions)
- Not accepted: stumps, dirt, sod, trash, metal, plastics, concrete, lumber, fences or wood scraps
- All yard waste (including loose leaves, pine needles, straw, plants and garden materials) must be placed in the separate leaf drop-off area when it's open.
