I am a member of MCI, Minnetonka Climate Initiative. We have reviewed the detailed Energy Action Plan (EAP) that the Minnetonka Energy Action and the Partners in Energy teams put together; thank you for all the hard work. MCI supports the city's efforts to address energy conservation measures to reduce CO2; this detailed, extensive plan is a very positive step towards carbon neutrality.

On behalf of MCI, below are our combined comments regarding the Energy Action Plan document that we hope you and the other PIE member will consider and apply. (These are in no particular order.)

- 1) The EAP document is very detailed yet misses a key issue that we believe should be stated very clearly that all energy conservation strategies implemented will reduce the amount of carbon dioxide (CO2) emitted into the atmosphere, and that reducing CO2 will contribute to slowing the rate of global warming-- because CO2 is the key cause of global climate change. Though we who work on this issue know that CO2 is the cause of global climate change, this is a simple explanation that, for the layperson, should be included. This could be a simple add to the introduction or the goals.
- 2) The EAP goal is to reduce energy-related greenhouse gas emissions in Minnetonka by 160,000 metric tons of CO2 equivalent before the end of 2030. That number means very little to a resident, since we do not understand the big picture of how much CO2 that is. If that summary goal on page 11 could include your reference to number of cars off the highway or some other lay term, it would have more impact to residents. People need to understand the goal to help achieve it.
- 3) Commercial/industrial makes up only 8% of premises but consumes 50% of energy (64% of electricity and 40% of natural gas). So why are multi-family strategies so robust, when business strategies are not? We appreciate your comments that a great deal of reductions have already been made with large business (page 9) but believe that continued businesses outreach should be included in your approach.
- 4) The EAP should recognize and address the effects of COVID and how the shift to working from home and driving less has changed energy use. Though we realize this occurred late in the process of developing the EAP, it is a real and significant factor in energy usage and therefore the CO2 reduction goals.
- 5) How does Minnetonka compare to our neighbors; are our goals reasonable/aggressive enough compared to similar programs?
 - a. Minneapolis includes plans for small and large businesses and 100% renewable

- electricity for the City enterprise by 2030 and 80% citywide by 2050.
- b. St Paul's plan focuses on achieving carbon neutrality in city operations by 2030 and citywide by 2050.
- c. St Louis Park's goals are to reduce overall carbon emissions by 55% by 2030 and a net zero carbon footprint by 2040.
 - i. Also note that SLP includes easy to understand goals, such as:
 - o Reduce energy consumption in residential buildings by 35%
 - Reduce energy consumption in small- to mid-size commercial buildings by 30%
- 6) Do other cities fund 'green' infrastructure to support CO2 reduction via energy efficiency or renewables incentives? Does the city plan to/can it take advantage of state programs, e.g. Guaranteed Energy Savings Program or promoting PACE (Property Assessed Clean Energy) financing?

Thank you for reviewing our suggestions and questions, Drew; please do not hesitate to reach out to MCI—either the group or the PIE team members—if you have any questions. We look forward to implementation of the EAP and to exceeding our carbon reduction goals.
