Nov. 3 is Election Day

The 2020 general election is Tuesday, Nov. 3, and it's our goal that every eligible Minnetonka voter can cast their ballot safely and securely during the COVID-19 pandemic.

Vote early

- Absentee in-person at the Minnetonka Council Chambers
 - Monday-Friday, 8 a.m.-4:30 p.m.
 - Direct balloting: Begins Tuesday, Oct. 27
 - Extended hours: Saturday, Oct. 31 (10 a.m.-3 p.m.) and Monday, Nov. 2 (8 a.m.-5 p.m.)
- Absentee by mail learn how at minnetonkamn.gov/election
 - Ballots must be postmarked by Election Day and received by Nov. 10 to count.
 - Completed ballots can also be dropped off during absentee in-person voting.

Vote on Election Day

- 7 a.m.-8 p.m. (If you're in line at 8 p.m., you're allowed to vote.)
- Find your polling place and a sample ballot at pollfinder.sos.state.mn.us.
- Learn how to register at the polls at minnetonkamn.gov/voters.

COVID-19 precautions

- Please wear a mask and practice social distancing.
- We'll have masks, hand sanitizer and pens for each voter.
- Election staff will follow CDC guidelines, wear personal protective equipment and disinfect surfaces regularly.

Minnetonka votes to adopt or reject ranked choice voting

On the 2020 ballot, Minnetonka voters will be asked to consider how city elections (mayor and city council) are conducted.

City council approves new sustainability commission

In October, the Minnetonka City Council approved an ordinance to create a new sustainability commission to further the city's efforts to protect and preserve the environment.

This new commission will:

- Review and provide input on sustainability proposals.
- Act as a sustainability ambassador to the community.
- Serve as a resource for existing city advisory groups.

Mark your curb for winter snow removal

Free curb markers are available at city hall (14600 Minnetonka Blvd.) and public works (11522 Minnetonka Blvd.). Please act quickly! They're much easier to install before the ground freezes.

City council sets 2021 property tax levy limit

Each September, in accordance with state law, the Minnetonka City Council is required to set a maximum preliminary tax levy before approving the following year's budget.

At its Sept. 21 meeting, the city council adopted a preliminary property tax increase of no more than 3.5 percent for 2021.



What does this mean for the average homeowner?

City property taxes for the median valued home in Minnetonka (\$390,000 for taxes payable in 2021) will decrease by approximately \$5* next year.

What's new in 2021?

The goal of the budget is to reduce the 2021 levy from prior projections without burdening future years. New initiatives include \$150,000 for diversity, equity and inclusion; \$127,000 for elections (pending 2020 election results) and \$50,000 to expand sustainability efforts. Adjustments to the Capital Improvement Program and a change in the city's health insurance provider allowed the city to reduce the levy increase by more than two percent.

*The exact impact on specific properties will depend on the assessed market value of each home. These numbers do not include the proposed increase from other taxing jurisdictions such as the county and local school district.

Cook up fire safety this season

The holiday season is almost here, and that means more time preparing big meals for family gatherings. Did you know cooking mishaps were the leading cause of structure fires in Minnesota in 2019, causing nearly \$6 million in damages?

These reminders from the Minnetonka Fire Department will help you cook up a healthy serving of fire safety in the kitchen this winter.

- Never leave the kitchen while cooking. If you have to step away, turn off the stove and remove pans from burners.
- Keep flammable items oven mitts, towels, wooden spoons, etc. - at least three feet from the stove, and avoid wearing loose-fitting clothes.
- Cover pan fires with a tight-fitting lid and turn off the heat.
- Ensure your smoke alarms are working properly on each level and in each bedroom.



Each fall, the city accepts leaves, yard waste and brush from Minnetonka residents at the Public Works Facility at 11522 Minnetonka Blvd. Residents must present a driver's license, state ID or utility bill. Commercial services must prove materials came from a Minnetonka address.

Time to prune trees

Tree pruning is an important part of home maintenance. Plan to prune in the winter, when trees - along with potentially harmful insects and diseases - are dormant. Branches should be pruned if they are diseased, broken, overlong or crowding each other.

Follow these tips and guidelines for successful pruning.

- Use the right tools, including eye protection, gloves, bypass hand pruners, folding hand saws, pole saws and bypass loppers. Avoid anvil pruners, which damage the wood.
- If pruning requires a ladder or chainsaw, call a professional.
- Don't remove more than a quarter of a tree's branches.
- Individual branch width should not exceed half the trunk diameter.
- Know your property lines, and consult state law before pruning or removing your neighbor's trees. Notify the city, county or state about pruning needs on someone else's property.

The city will prune trees and shrubs along the right-of-way from November to March to improve sightlines, clear dead and broken branches and prepare for upcoming construction projects.
