- Ranked choice voting: 54.71 percent (18,475 votes) voted yes; 45.29 percent (15,293 votes) voted no
- Voter turnout: 89.15% percent (37,602 votes out of 42,178 registered voters)
- Percent that voted absentee: 66.07 percent (27,867 votes)
- Absentee ballots distributed and not yet returned/counted: 1,290
- New voter registrations since August 2020 primary: 3,670
- Recent general election turnout for comparison: 87.5 percent in 2016; 89.4 percent in 2012; 82.3 percent in 2008.
