Ranked choice voting adopted by Minnetonka voters

Election Day 2020 was Tuesday, Nov. 3, and a majority of Minnetonka residents voted to adopt the use of ranked choice voting for city elections (mayor and city council) beginning November 2021.

Adoption of ranked choice voting received 54.7 percent of the vote (18,475 total votes), while 45.3 percent (15,293 total) voted to reject the change and continue using the city's current election system.

Under ranked choice voting, voters will be asked to rank mayoral and city council candidates in order of

preference on their ballots, and primary elections will no longer be used. The city council will adopt an ordinance to establish rules and procedures.

Please remember, ranked choice voting only impacts mayor and city council elections. It will not change the way you vote for school board, county, state or federal offices.

2021 budget summary and public hearing

In September, the city council adopted a preliminary property tax increase of no more than 3.5 percent for 2021.

The council will vote on adoption of the final 2021 budget and levy at its Dec. 7 meeting.

What does this mean for the average homeowner?

City property taxes for the median valued home in Minnetonka (\$390,000 for taxes payable in 2021) will decrease by approximately \$5* next year.

What's new in 2021?

The goal of the budget is to reduce the 2021 levy from prior projections, without burdening future years. New initiatives include \$150,000 for diversity, equity and inclusion; \$127,000 for elections and \$50,000 to expand



sustainability efforts. Adjustments to the Capital Improvement Program and a change in the city's health insurance provider allowed the city to reduce the levy increase by more than two percent.


*The exact impact on specific properties will depend on the assessed market value of each home. These numbers do not include the proposed increase from other taxing jurisdictions such as the county and local school district.

Here's how we're funded


Projected 2021 Revenue

Get ready for winter snow removal

Please keep the following items in mind as winter weather approaches:

- Plowing operations typically begin between midnight and 4 a.m. (but it can vary).
- Above-average snowfalls may require a multi-day operation to clear (in this order) streets, parking lots, sidewalks, trails and ice rinks.



- Snow removal takes place in three steps: a first pass to provide access, full-width plowing and cleanup.
- Snow cleared from your property must remain on your property. Don't push it into the street or onto sidewalks and trails, where it could interfere with traffic or plows.
- The city will repair damage to curbs and sod caused by city snowplows. Mailboxes damaged by direct contact with city snowplows will also be repaired. Damage to private improvements (fences, sprinklers, rock gardens, etc.) in the rightof-way are the responsibility of the property owner.
- Place curb markers to show plows the edge of your lawn or driveway. These are available for free at city hall. Try to install before the ground freezes.



- Plowing will result in snow at the end of your driveway. Unfortunately, this is unavoidable and clearing the driveway is the property owner's responsibility. Plows will try to evenly distribute snow in cul-desacs when possible.
- Set garbage and recycling cans behind the curb line so they don't interfere with plows.

Winter parking reminders

- Vehicles can't be parked on a public street between 2 a.m. and 6 a.m., or in one place for more than six hours.
- Parked vehicles and trailers can't interfere with the removal of snow, sleet, slush or ice and may be towed at the owner's expense.



Save money and energy

Schedule a virtual or in-person visit with the Home Energy Squad to improve your home's energy efficiency and save money on your utility bills.

Virtual visits

Discover low cost energy-saving opportunities and identify future projects to save even more. These free visits typically last 1-2 hours and include:

- A pre-visit questionnaire
- A virtual walk-through of your home with energy experts
- A customized report with recommendations and next steps



Home visits

The city will pay half of the \$100 fee for the first 280 homes to schedule an in-person home evaluation. Home Energy Squad staff will wear masks, wash hands and social distance. These visits include:

- Installation of energy saving materials (LED light bulbs, weather stripping, programmable thermostat, etc.)
- Blower door test (to check for air leaks)
- A customized report with recommendations

Southwest Light Rail Transit update

The Metropolitan Council's Southwest Light Rail Transit (SWLRT) project is now fully funded and construction continues. Minnetonka highlights include:

- Opus Station platform construction
- Shady Oak Station construction



- Highway 62 tunnel excavation and construction
- Smetana Road and Feltl Court bridge construction

Most construction activity will continue through November, then pause for the winter. Some tasks, including Highway 62 tunnel construction, will continue throughout.

Practice holiday-season fire safety

In addition to festive gatherings and decorations, the holiday season also brings increased fire risk. Follow these tips to ensure a fun and safe holiday season!

- **Decorations**: Choose flame-resistant materials. Keep away from lit candles, fireplaces, stoves, windows and doors.
- Lights: Hang with clips instead of nails. Ensure indoor- and outdoor-only lights are used in the proper setting. Replace lights with worn or broken cords or loose bulb connections. Turn off lights before leaving or going to bed.



• Entertaining: Ensure

all smoke alarms are working properly. Tell guests about your home's fire escape plan. Never leave the kitchen while cooking; if you have to step away, turn off the stove and remove pans from burners.

How we protect our community forest

The city's plant pest program limits the spread of Dutch elm disease, oak wilt and emerald ash borer, and prepares for emerging threats to our community forest.

Dutch elm disease (DED) has steadily declined in Minnetonka thanks to an ordinance that requires removal of diseased elms within 30 days. From 2017 to 2020, DED-marked trees have decreased by 70 percent.

Oak wilt occurs in oak trees with fresh wounds from broken or cut limbs and often spreads through shared root systems to nearby trees. Strong summer winds and storms contributed to unusually high oak wilt rates in 2020.

Emerald ash borer (EAB) has been confirmed in Minnetonka, and our staff is scouting for EAB citywide. If you have an infested ash tree, we'll notify you and provide a timeline for winter removal. We'll also work with property owners to manage ash along roads.

Tree protection and planting are also key components of our forestry program. We planted 75 young trees from 20 different species in city parks and public spaces in 2020, and our annual tree sale (held each February) offers diverse tree species to residents at a reduced price. We've also treated numerous ash trees to prevent EAB; treated ash trees are marked with a green band.




Provide input on new regional trail
