Subject: Ranked Choice Voting Ordinance

Mayor, Councilmembers and staff,

We're very excited to see the formal ordinance for Ranked Choice Voting! As community members with some experience on the topic, we just wanted to offer a few points of feedback.

- First, this is a well-drafted ordinance. We shared it with knowledgeable experts on the subject and they were highly complimentary. Thanks to staff who worked on the details!
- Second, we would echo the staff's suggestion to keep with the Hennepin county version of the tiebreaking process, and not adopt the St. Paul process. It's a small thing, but changing the process to align Minnetonka with St. Paul would represent a change to the underlying counting program, and this can only create problems.
- Third, we would strongly encourage the ordinance to allow for "at least three" rankings instead of just three, just as Minneapolis does in their ordinance to provide forward-looking flexibility. The justification provided for allowing only 3 rankings is the current ballot design limitations, which could make it harder to navigate with more than 3 rankings. However, Minneapolis and other cities are likely to adopt new systems and technologies soon, and this will enable a simplified ballot design for more than 3 rankings. This is why the current Minneapolis ordinance reads "When there are three (3) or more qualified candidates, a ballot must allow a voter to rank at least three (3) candidates for each office in order of preference and must also allow the voter to add write-in candidates." For all the same reasons that we adopted ranked choice voting (more choices, greater inclusivity), it gets better when we provide more rankings should that become possible and/or necessary in the future. In the "administrative rules and procedures" section of the proposed Minnetonka ordinance, it provides administrative latitude to the city clerk to make exactly these kinds of judgement calls in the future, so it would seem to make sense to give the clerk the power to decide the number of rankings based on a practical issue like ballot design.

Again, our compliments to the staff for drafting such a thorough ordinance.
