Minnetonka police begin using body cameras

Beginning in early 2021, Minnetonka police officers began using body-worn cameras to capture video and audio evidence. The goal of this new policy and equipment is to improve criminal investigations, police transparency and public trust.

"People will begin to notice officers wearing cameras as they are out in the community. We are pleased to add them to our toolbox," said Scott Boerboom, Minnetonka's chief of police. "This is a step that will not only assist us with investigations but also help us continue to build relationships all across our community."

The department's in-car video systems - which have been in use for years - were also upgraded and integrated with the new body-worn cameras.

The policy was developed in early 2020, and a draft was presented to residents to review and provide feedback. The city council reviewed the draft at its May 11, 2020 study session, and accepted public comment at its June 22, 2020 meeting.

AARP tax appointments full

AARP Foundation Tax-Aide typically offers free tax preparation at the Minnetonka Community Center. Due to the COVID-19 pandemic, AARP was only able to offer limited assistance by appointment, and all appointments have been filled.

If you relied on this service in the past, you should make alternate plans to prepare and file your 2020 federal or state tax return. Hire an accountant, ask family or friends for help, or use an online service, such as the free online software from AARP and the IRS.

Apply for home improvement and purchasing loans

Are you planning a home improvement project or looking to buy your first home? The city has a pair of low-interest loan programs to help qualified applicants. Income and asset limits apply.

Apply for a deconstruction grant

Deconstruction is the process of carefully dismantling building structures to salvage materials for reuse. To promote this unique form of recycling, Hennepin County is offering grants to help offset deconstruction's additional time and labor costs.

Homeowners and developers can apply to receive grants up to \$5,000. Projects must be 500 square feet or larger on structures built prior to 1950 and must meet other criteria.

Look for tax notices this month

Residents will receive two notices this month related to property taxes. One is the market value notice from the city, which will affect property taxes to be paid in 2022. The other is the property tax bill for 2021, which is mailed by Hennepin County and must be paid this year.

The city accounts for a little less than 29 percent of a homeowner's total property tax bill. The rest includes taxes for your school district (33 percent), county (32 percent) and other jurisdictions (six percent).

2021 market value notice - applies to 2022 property taxes

Property tax in Minnesota is a complicated process governed by state law. Although the City of Minnetonka administers the assessment, Hennepin County and the Minnesota Department of Revenue oversee the process.

The Minnetonka real estate market continues to thrive, with nearly all property types increasing in value.

Average 2021 value changes by property type

- Single-family homes 4% increase
- Townhouses 5% increase
- Condominiums 6% increase
- Commercial 2% decrease
- Apartments 2% increase
- Industrial 4% increase

Keep in mind, individual properties may vary greatly, and adjustments vary by market.

How is market value determined?

The city's assessing division maintains records for every property in Minnetonka. Adjustments are made to the market value of most properties based on actual real estate sales of comparable properties from the past year.

At least 20 percent of all properties are physically inspected each year and adjusted based on the results of those inspections. Market value adjustments are also made for building additions, remodeling and other improvements.

What if I don't agree with my property's market value?

If you have questions or concerns about your property's market value notice or the assessment process, call 952-939-8220. Assessing staff will review property records and sales information with you. Based on the review, the appraiser may or may not make a change to your market value. If not, you have the right to appeal.

Water efficiency rebates available

It pays to improve the efficiency of your lawn's sprinkler system ... literally.



In 2021, Minnetonka property owners who install WaterSense certified sprinkler heads and/or smart controllers can apply for a rebate from the city. WaterSense products are EPA-certified, highperforming products that use at least 20 percent less water.

In Minnetonka, residential water use triples in the summer, so it's important to start thinking about improvements before lawn-watering season arrives. Adjustments to your existing systems, or investments in equipment or technology, can make a big difference for our environment, and your water bill.

Inspect your sprinkler system annually to ensure it's working properly and don't over-water - most plants and trees only need one inch of water per week from a combination of rain and irrigation.

Resilient landscaping

Grass lawns provide a nice, tidy aesthetic and space for recreation but they also need a lot of maintenance, which can impact the environment. If you're considering landscaping changes on your property in 2021, consider these attractive, low-maintenance alternatives.

Choose fescue

Fescue is a type of grass that tolerates cold weather, heat and drought. You can replace existing turf with fescue, or add fescue seed to your lawn's shady, wet or problem spots. Fescue doesn't require fertilizer and tolerates road salt better than more-common grasses.

Fescue lawns can be kept at a height of three inches to encourage root growth, hold moisture in the soil and reduce erosion. Mowing at that height also reduces fossil fuel emissions to help our air quality.

Plant for pollinators

Consider adding pollinator-friendly plants to your yard, such as lowgrowing legumes and perennial herbs, including Dutch white clover, self-heal (in the mint family) and wild violet.

Another option is to replace traditional turf with meadow vegetation, which is similar to this region's native prairie.

Fertilizers and pesticides should not be used in pollinator habitat, and pollinator habitat in public view must be marked with a lawn sign. Email cpetersen@minnetonkamn.gov to request a sign.
