



Water main flushing begins April 19

Minnetonka Public Works will flush water mains throughout the city from Monday, April 19 through Friday, May 7. Flushing will take place weekdays from 5:30 a.m. to 5 p.m. in most areas. See the map to determine dates in your area.



Flushing in these areas will occur at special times: **April 19** Ridgedale business area

5:30 a.m.-5 p.m.

April 26

Minnetonka Industrial Road, Twelve Oaks Center Drive and Carlson Parkway 5 a.m.-5 p.m.

May 4

Hutchins Drive 4 a.m.-5 p.m.

May 6

Opus, Beachside, K-Tel, Clearwater Drive, Whitewater Drive and Culligan Way 3 a.m.-3 p.m.

Schedules may be adjusted due to weather. During flushing its normal to experience some discolored water, which is safe to drink and can be cleared up by running cold water in your laundry tub. Call 952-988-8400 to learn more or ask questions.

Street sweeping under way

Minnetonka Public Works will begin street sweeping in late March, weather permitting. For four weeks - or until all streets have been swept - crews will sweep streets in 10-hour shifts Monday through Thursday (5 a.m. to 3 p.m.) and in eight-hour shifts on Fridays (5 a.m. to 1 p.m.). Crews try to stay out of residential areas in the early morning, but it is not always possible. In these cases, crews will make every effort to minimize noise.

While the street sweeper does a good job cleaning streets, it can't capture all the debris, so we need your help! As the snow melts, identify the storm sewer grates in your neighborhood, then remove and dispose of the accumulated debris and litter.

DID YOU KNOW?



Recreational fire permits must be renewed annually.

Permits are free, valid until Dec. 31 each year and must be applied for or renewed online. Natural gas and propane fire pits and fireplaces do not require a permit.

When you complete the online application, request a copy of your submission and print or save the emailed copy of the permit for your records. If you don't receive the email, check your junk and spam folders or complete the form again.

Keep your dryer fire-free

Laundry seems like a harmless household chore, but dryers can present a fire risk if not properly used and maintained. Follow these tips from the Minnetonka Fire Department to keep your dryer and vent fire-free.



- Always use a lint filter; check and clean the lint filter before and after each use.
- Ensure the outdoor vent cover opens when the dryer is in use.
- Have your dryer vent pipe professionally cleaned annually, especially if it's taking longer than normal to dry your clothes.
- Only dryer vent clamps or tape should be used to connect the sections of vent pipe. Screws can collect lint, prevent proper use and create a fire risk.

Be a good neighbor in 2021

The past year has been challenging in many ways for all of us. We encourage you to be a kind and considerate neighbor by complying with city ordinances, and offering to help those who need it.

Common neighborhood complaints - and how you can avoid them - are listed below.

Trash and recycling bins

All garbage and recycling containers must be stored completely out of public view, either inside a garage or behind a screened enclosure, except the evening before and the day of collection.

Outside storage

Outside storage of personal property is not allowed in Minnetonka, unless the items are used for normal outdoor recreational activities on the property, such as outdoor furniture, cooking equipment and recreational equipment.

Vehicle Storage

Vehicles stored outside must be in operable and licensed condition. Vehicles stored in the front of the home must be on asphalt, concrete or gravel, but can be stored on the lawn alongside or behind the house. No more than four vehicles are allowed per property, unless you have visitors.

Brush piles and lawn debris

Piles of brush or other organic material are prohibited, except for properly maintained compost piles. Leaves and grass may not be left in the street, right-of-way, in wetlands, on public property or on other people's property. Trash, rubbish or refuse must be removed from any property.

Noise

Minnetonka's "quiet hours" are 10 p.m. to 7 a.m., seven days a week, all year. Exemptions include refuse haulers and snow plows.

Leaf and brush drop-off sites open April 3

Each spring and fall, the city accepts leaves, yard waste and brush from Minnetonka residents at the Public Works facility. Residents must present a driver's license, state ID or Minnetonka utility bill. Commercial tree and lawn services must prove materials came from a Minnetonka address.

The drop-off site will be closed May 31, July 5 and Sept. 6 in observance of holidays.

LEAF DROP-OFF SITE OPEN APRIL 3-MAY 15

Leaf Drop-off Site Guidelines

- Accepted: leaves; yard waste such as grass, weeds, pine cones, needles, straw, plants and garden materials; sticks and branches smaller than one half-inch in diameter
- Not accepted: bags of any kind residents **must** take all bags home, including compostable bags; sod, dirt, trash, concrete, wood; noxious weeds, including garlic mustard and thistle; sticks and branches **larger than one half-inch in diameter** must go to the separate brush drop-off
- Remember to bring proper equipment to unload (i.e. pitchfork, shovel, etc.)
- Items **must** be covered during transport.

BRUSH DROP-OFF SITE OPEN APRIL 3–NOV. 20

- Accepted: trees and branches up to eight feet in length (no diameter restrictions)
- Not accepted: stumps, dirt, sod, trash, metal, plastics, concrete, lumber, fences or wood scraps
- All yard waste (including loose leaves, pine needles, straw, plants and garden materials) must be placed in the separate leaf drop-off area when it's open.
