### City unveils new public safety facility

In early September, the City of Minnetonka officially opened its new fire and police facility, capping off an 18-month construction project dedicated to improving public safety.

The project included the construction of a new fire station and repurposing of the existing police and fire facility into a remodeled police station.

priorities, particularly in the delivery of emergency response services," said former City Manager Geralyn Barone, who retired in September.

The facility also emphasizes firefighter health and wellness with the addition of a decontamination area that will reduce exposure to toxic agents.

With the fire department shifting

to its new home, its former station and the police facility were remodeled to accommodate the needs of a 21st-century police department.

The revamped police building features modern technology and additional meeting space to provide increased training and

information sharing opportunities.

"The layout of the building is much more efficient," said Police Chief Scott Boerboom. "We can now maintain all our equipment in one secure location and better serve our residents."

The new facility also highlights the city's continued focus on sustainability by using local materials, low-energy fixtures and a white roof to improve cooling efficiency. One of the building's most unique features is the wood wall accents milled from onsite trees removed during the expansion.

The improved stations are the latest evolution in the city's ongoing investment in public safety, ensuring departments are best equipped to serve the community for many years

## Vote early in the 2021 election

Three city council seats are up for election this year - mayor and two at-large seats. Election Day is Tuesday, Nov. 2, but anyone can vote absentee early.

#### Vote absentee in-person

Cast your absentee ballot in-person now through Nov. 1 at 14600 Minnetonka Blvd., Monday-Friday, 8 a.m.-4:30 p.m. Direct balloting - where you place your ballot in the tabulator - begins Oct. 26. While direct balloting is faster, our lines are generally longer.

City hall will be open extended hours Saturday, Oct. 30 (10 a.m.-3 p.m.) and Monday, Nov. 1 (8 a.m.-5 p.m.) to accommodate voters.

#### **Absentee voting by mail**

Hennepin County manages absentee (early) voting by mail. You can download an absentee ballot application form at **hennepin.us/residents/elections/absentee-voting** or call 612-348-5151. Ballots must be returned by Election Day to count.

#### **Election Day is Tuesday, Nov. 2**

Polls will be open from 7 a.m.-8 p.m. Two polling locations have changed from 2020:

- Ward 1: Precinct E voters will vote at Minnetonka Public Works, 11522 Minnetonka Blvd.
- Ward 3: Precinct B voters will vote in the Minnetonka Council Chambers, 14600 Minnetonka Blvd.

#### **Ranked choice voting**

Minnetonka voters will use ranked choice voting (RCV) to identify their candidates of choice. A sample ballot and information about the RCV process was mailed to all Minnetonka residences in mid-September. Residents can also find a sample ballot at myballotmn.sos.state.mn.us.

# City council focuses on public safety with 2022 property tax levy

Each September, the city council is required to set a maximum preliminary tax levy before approving the following year's budget. This year, the council set the 2022 preliminary tax levy at its Sept. 13 meeting.

The levy calls for a 5.6 percent increase, due in part to a focus on public safety. To improve emergency response times, the fire department is looking to hire a minimum of nine full-time staff. The city has applied for a federal Staffing for Adequate Fire and Emergency Response (SAFER) grant, which would fully fund 13 positions for three years and reduce the city's 2022 preliminary levy impact.

"Increasing our full-time staffing will allow us to remain proactive and reduce the response time of fire crews first arriving on scene," said Fire Chief John Vance.

The council will continue to review and discuss 2022 city property taxes and finances prior to final adoption in December.

Property owners will receive proposed 2022 tax notices from Hennepin County in November.

## Meet your police department's newest recruit

This summer, the Minnetonka Police Department's newest recruit hit the ground running - on all four paws.

Meet Mattis! He's an 11-month-old Belgian Malinois, who arrived from the Czech Republic in early August. Mattis is the department's second K9 and will partner with Minnetonka Police Officer Eric Finnvik.

Mattis isn't ready for the field quite yet. He and Officer Finnvik are currently attending an intense, 12-week training program that focuses on obedience, drug detection, locating discarded evidence, tracking and suspect apprehension.



Once his training is complete, Mattis will be certified by the United States Police Canine Association, and his primary role will be helping officers locate people and evidence.

"As my partner, Mattis will respond to daily and emergency calls," Finnvik said. "He'll be asked to find and possibly apprehend suspects involved in crimes, locate evidence and aid in locating missing persons."

Minnetonka has had a K9 program since 1976. K9s live with their partner's family and typically work the night shift.

"It's very clear Mattis is driven to excel in his new role," Finnvik said. "We're excited to put his skills to use throughout the community."

## Get first year of organics recycling free

To encourage organics recycling, the city and Hennepin County are offering a free year of service to the first 200 new customers in 2021. Which means, there's still time to get in on this environmentally friendly deal. Here's how to sign up:

- You must use Randy's Environmental Services (763-972-3335) as your garbage hauler. Contact them directly to begin curbside organics collection.
- The city will pay Randy's directly; you will not be billed.



## Why sign up? Because organics recycling ...

- Provides the best opportunity to reduce our trash Waste sort studies, like the one Hennepin County conducted in 2016, continue to show that organic materials are the largest proportion of our trash making up about 25 percent of the trash stream.
- Reduces greenhouse gas emissions
   Organic materials decomposing in landfills generate methane, a potent greenhouse gas. Diverting

organics to composting helps to reduce landfill methane emissions.

#### • Improves soil and protects water

When compost is added to soil, it reduces the need for fertilizers and pesticides. It also increases the water retention of soils, which reduces runoff and erosion that can pollute our water and helps to conserve water.

#### Supports a local economy

Minnesota's composting industry supports about 700 jobs and produces \$148 million in gross economic activity per year. The composting industry supports four to eight times more jobs on a per ton basis than landfilling operations.

# **Drop off leaves throughout October**

Each fall, the city accepts leaves, yard waste and brush from Minnetonka residents at the Public Works Facility at 11522 Minnetonka Blvd. Residents must present a driver's license, state ID or Minnetonka utility bill. Commercial tree and lawn services must prove materials came from a Minnetonka address.

Keep leaves and yard waste separate from brush and drop off in their respective areas. Bags cannot be left at the drop-off site, including compostable bags.

## This fall, think about spring

Fall yard work is crucial in Minnesota to protect your plants against the elements of winter and prepare them to thrive the following spring.


As you embark on your outdoor fall chores, follow these tips to remedy small problems or begin changes that will bear fruit in the future.




- Seed (or overseed) bare spots in your lawn. Try fescue grasses in shady or damp spots where conventional grass hasn't thrived.
- Pull weeds when the ground is moist ideally, after it rains. Place weeds in plastic bags and deposit in the trash.



- If you need to use herbicide, spot-spray problem areas rather than applying broadly. Don't do it when it's windy or rainy to avoid the spread of chemicals.
- You can plant trees, shrubs and perennials in the fall if they are properly mulched and receive an inch of water per week until the ground freezes. Add wire caging around woody plants to protect from wildlife.







 Rather than clearing perennials, cut them to 8-12 inches high. Bees can spend the winter inside the dried stems.
